A BILL FOR AN ACT

To amend Public Law No. 7-96 by amending sections 1 and 5, and by adding a new section 5, for the purpose of modifying the use of certain funds previously appropriated therein, by renumbering section 6, and for other purposes.

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

All funds appropriated by this act shall be 4 allotted, managed, administered, and accounted for in 5 accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. The allottee of the funds appropriated under subsections (1) and (2) of 8 section 1 of this act shall be the respective school board 9 of each institution; the allottee of the funds appropriated 10 under subsection (4) of section 1 of this act shall be the 11 12 Southern Namoneas Development Authority; the allottee of the funds appropriated under subsection (5) of section 1 of 13 this act shall be the President of the Federated States of 14 Micronesia or the President's designee; and the allottee of 15 the remaining subsections of section 1 shall be the 16 Governor of Chuuk State. Lower Mortlocks Development Authority. The allottees shall			
be responsible for ensuring that these funds, or so much			
thereof as may be necessary, are used solely for the			
purpose specified in this act, and that no obligations			
are incurred in excess of the sum appropriated. The			
authority of the allottees to obligate funds appropriated			
by this act shall lapse as of September 30, 1994."			
Section 4. Section 6 of Public Law No. 7-96 is hereby renumbered			
as section 7.			
Section 5. This act shall become law upon approval by the			
President of the Federated States of Micronesia or upon its becoming			
law without such approval.
