Public Law No. 7 - 87

AN ACT

To appropriate the sum of \$3,000,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1993, for the purpose of purchasing additional equity in the Bank of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$3,000,000, or so much thereof as may be
- 2 necessary, is hereby appropriated from the General Fund of the
- 3 Federated States of Micronesia for the fiscal year ending September
- 4 30, 1993, for the purpose of purchasing stock in, or otherwise
- 5 providing equity for, the Bank of the Federated States of Micronesia.
- 6 Such purchase shall be made by the President of the Federated States
- 7 of Micronesia in the name of the Government of the Federated States
- 8 of Micronesia, and the President of the Federated States of Micronesia
- 9 shall cause to be entered on the books and records of the Bank of the
- 10 Federated States of Micronesia the name of the Federated States of
- 11 Micronesia as the owner of any interest in the Bank of the Federated
- 12 States of Micronesia acquired pursuant to this act. The funds
- 13 appropriated under this section shall be deemed to come from the
- 14 capital account of the Compact of Free Association.
- 15 Section 2. All funds appropriated by this act shall be allotted,
- 16 managed, administered, and accounted for in accordance with applicable
- 17 law, including, but not limited to, the Financial Management Act of
- 18 1979. The allottee of the funds appropriated under this act shall be
- 19 the President of the Federated States of Micronesia or his designee,
- 20 who shall be responsible for ensuring that these funds, or so much
- 21 thereof as may be necessary, are used solely for the purpose specified
- 22 in this act, and that no obligations are incurred in excess of the sum

2	appropriated by this act shall not lapse.
3	Section 3. This act shall become law upon approval by the
4	President of the Federated States of Micronesia or upon its becoming
5	law without such approval.
