A RESOLUTION

To ratify and accede to the Articles of Agreement establishing the Multilateral Fishery Treaty between certain Pacific Island States and the Government of the United States (hereinafter referred to as the Multilateral Fishing Treaty), as amended.

- 1 WHEREAS, the Multilateral Fishing Treaty was already
- 2 ratified by the Congress of the Federated States of Micronesia
- 3 in past years; and
- WHEREAS, the Parties met in December of 1991 and May of 1992
- 5 to consider an extension of the Multilateral Fishing Treaty and
- 6 have agreed to extend said treaty for a period of 10 years, with
- 7 a review before the fifth year, starting from June 15, 1993
- 8 respecting the financial and licensing arrangements; and
- 9 WHEREAS, the Multilateral Fishing Treaty itself was not
- 10 amended but its annexes and schedules; and
- 11 WHEREAS, the United States Government have agreed to make
- 12 annual cash payments to the Forum Fisheries Agency (FFA) in an
- 13 average amount of \$18,000,000, an increase over the current
- 14 \$10,000,000; and
- WHEREAS, the amendments to the Annexes of the Multilateral
- 16 Fishing Treaty include the following: a new Part 4 regarding
- 17 transhipment of fish; a new subpart under Part 7 entitled
- 18 Observers, which imposes responsibility for the cost of
- 19 observers including full travel costs, salary and allowances,
- 20 full insurance coverage, and the cost of training observers on
- 21 the operators of U.S. vessels; a new subpart under Part 8
- 22 entitled Miscellaneous Requirements, which establishes a region-
- 23 wide vessel tracking system which shall be applicable to all
- 24 U.S. vessels licensed to fish in the treaty area; and a new
- 25 paragraph regarding suspension of good standing of a vessel

when a violation has occurred; and WHEREAS, the Multilateral Fishing Treaty shall enter into 2 force on June 15, 1993 and shall remain in force for 10 years 3 4 unless amended or terminated by either party; and WHEREAS, the Multilateral Fishing Treaty as amended is in 5 the best interest of the FSM National Government; now, therefore, 7 8 BE IT RESOLVED by the Seventh Congress of the Federated States of Micronesia, Fourth Special Session, 1993, that 9 pursuant to section 2(b) of Article IX of the FSM Constitution 10 the Congress hereby ratifies the Multilateral Fishing Treaty 11 12 between certain Pacific Island States and the United States; and 13 BE IT FURTHER RESOLVED that a certified copy of this resolution be transmitted to the President of the Federated 14 15 States of Micronesia and the Director of the Forum Fisheries 16 Agency. 17 Date: 3/18/93 Introduced by: 18 Joseph 19 20 21 22
