A BILL FOR AN ACT

To further amend Public Law No. 5-89, as amended, by further amending section 6, as amended by Public Laws Nos. 5-99, 5-126, 6-47, 6-78, and 7-56, to change the use of certain funds previously appropriated for Chuuk State public projects, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 6 of Public Law No. 5-89, as amended by
2	Public Laws Nos. 5-99, 5-126, 6-47, 6-78, and 7-56, is hereby further
3	amended to read as follows:
4	"Section 6. Halls, Western Islands and Namonwitto public
5	projects. The sum of \$200,000, or so much thereof as may be
6	necessary, is hereby appropriated from the General Fund of
7	the Federated States of Micronesia for the fiscal year
8	ending September 30, 1989, for the purpose of funding
9	certain public projects in the Halls, Western Islands and
10	Namonwitto, Truk State. The sum appropriated by this
11	section shall be apportioned as follows:
12	(1) Hall Islands Development Authority \$ 10,000
13	(2) Weito Islands Development Authority (WDA)
14	(a) Purchase and maintenance of dump
