AN ACT

To appropriate the sum of \$736,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1993, for the operations and office construction of the community action agencies in the four States, and to address other needs in the States, and for other purposes.

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. The sum of \$736,000, or so much thereof as may
2	be necessary, is hereby appropriated from the General Fund of the
3	Federated States of Micronesia for the fiscal year ending
4	September 30, 1993, for the operations and office construction of
5	the community action agencies in the four States, and to address
6	other needs in the States. The sum appropriated by this section
7	shall be apportioned as follows:
8	(1) Community action agency in Kosrae State\$ 60,000
9	(2) Community action agency in Pohnpei State 125,000
10	(3) Pohnpei CAA reimbursement to Yap CAP 15,000
11	(4) Pohnpei CAA office construction 71,000

6	None of the funds appropriated under subsection (2) of this section
7	shall be expended until all Pohnpei Community Action Agency board
8	members with expired terms have been reappointed or replaced with

10	Section 2. All funds appropriated by this act shall be
11	allotted, managed, administered, and accounted for in accordance with
12	applicable law, including, but not limited to, the Financial
13	Management Act of 1979. The allottee of the funds appropriated under
14	this act shall be the President of the Federated States of Micronesia
15	or his designee, who shall be responsible for ensuring that these
16	funds, or so much thereof as may be necessary, are used solely for
17	the purpose specified in this act, and that no obligations are
18	incurred in excess of the sum appropriated. The authority of the
19	allottee to obligate funds appropriated by this act shall not lapse.
