
A RESOLUTION

To ratify the Charter of the United Nations as adopted and entered into force in 1945.

1 WHEREAS, the Charter of the United Nations establishes
2 and governs the preeminent World Organization known as the
3 United Nations; and

4 WHEREAS, ratification of the Charter of the United
5 Nations is a prerequisite for a nation to join the United
6 Nations; and

7 WHEREAS, most sovereign and independent nations have
8 joined the United Nations; and

9 WHEREAS, the Federated States of Micronesia wishes to
10 take its place as a universally recognized and fully
11 functioning member of the International Community by joining
12 the United Nations; and

13 WHEREAS, the principles of the United Nations are basic
14 to the happiness, harmonious relations and security of all
15 peoples; and

16 WHEREAS, the objective of the United Nations is the
17 attainment of peace, security and human welfare; and

18 WHEREAS, some of the purposes of the United Nations
19 are:

20 (1) To maintain international peace and security,
21 and to the end: to take effective measures for the prevention
22 and removal of threats to the peace, and for the suppression
23 of acts of aggression or other breaches of the peace;

24 (2) To develop friendly relations among nations
25 based on respect for the principle of equal rights and self-

1 determination of peoples; and to take other appropriate
2 measures to strengthen universal peace; and

3 (3) To achieve international cooperation in
4 solving international problems of an economic, social,
5 cultural, or humanitarian character, and in promoting and
6 encouraging respect for human rights and for fundamental
7 freedoms from all without distinction as to race, sex,
8 language or religion; and

9 WHEREAS, it will be of great benefit for our Nation to
10 become a member of the United Nations to seek the advancement
11 of our people economically, socially, and politically; now,
12 therefore,

13 BE IT RESOLVED by the Seventh Congress of the Federated
14 States of Micronesia, First Regular Session, 1991, that
15 pursuant to section 2(b) of article IX of the Constitution of
16 the Federated States of Micronesia, the Congress hereby
17 ratifies the Charter of the United Nations, 1945; and

18 BE IT FURTHER RESOLVED that upon receipt of this
19 resolution the President of the Federated States of
20 Micronesia shall lodge, when appropriate, a letter of
21 application for membership in the United Nations, indicating
22 the intention of the Federated States of Micronesia to
23 observe faithfully all the obligations of membership, to
24 abide by the Charter and to cooperate fully in the attainment
25 of its aims and objectives; and


