A RESOLUTION

Respectfully requesting the President of the Federated States of Micronesia to undertake a total review of the organization and operations of the executive branch of the National Government and to make a report and recommendations for structural reorganization with the idea of reducing the bureaucracy, size, operational costs, and increasing the efficiency of the executive branch of the National Government.

1 WHEREAS, a new administration has taken office and is currently
2 setting up its organization and operations of the executive branch of
3 the National Government; and

4 WHEREAS, the start of this new administration presents an
5 opportune time to review and evaluate the current organizational
6 structure and operations of the executive branch of the National
7 Government; and

8 WHEREAS, there has been growing concern that the National
9 Government is too large, involves unnecessary duplication of effort,
10 and may be carrying out functions which can be more efficiently
11 handled by the States, thereby increasing unnecessary paper work
12 and red tape; and

13 WHEREAS, the Nation faces step-downs in funding under the
14 Compact of Free Association and reductions in other revenue sources
15 for the Nation; and

16 WHEREAS, there is a desire by the Congress to work with the new
17 administration in a cooperative effort to evaluate the current
18 organization and operations of the National Government so that costs
19 can be reduced and efficiency increased; now, therefore,

20 BE IT RESOLVED by the Seventh Congress of the Federated
21 States of Micronesia, Second Regular Session, 1991, that the Congress
22 hereby respectfully requests the President of the Federated States of
23 Micronesia to undertake a total review of the organization and
24 operations of the National Government and to make a report and
25 recommendations for structural reorganization with the idea of




1 reducing the bureaucracy, size, operational costs, and increasing the
2 efficiency of the National Government; and

3 BE IT FURTHER RESOLVED that such a report and recommendations be
4 transmitted to the Congress by January 31, 1992; and

5 BE IT FURTHER RESOLVED that certified copies of this resolution
6 be transmitted to the President of the Federated States of Micronesia,
7 the Speaker of the Congress of the Federated States of Micronesia, the
8 Chief Justice of the Supreme Court of the Federated States of
9 Micronesia, the Governors of the four States of the Federated States
10 of Micronesia, the Speakers of the four State legislatures of the
11 Federated States of Micronesia, the President of the Senate of the
12 Chuuk State Legislature, the Chief Justices of the State courts of
13 the Federated States of Micronesia, and the Chief Executive Officers
14 of the municipalities of the States of the Federated States of
15 Micronesia.
