

A BILL FOR AN ACT

To further amend Public Law No. 4-95, as amended, Chuuk State public projects, by further amending section 3, as amended by Public Law No. 5-29, to change the allottee of funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 4-95, as amended by Public
2 Law No. 5-29, is hereby further amended to read as follows:

3 "Section 3. All funds appropriated by this act shall be
4 allotted, managed, administered, and accounted for in
5 accordance with applicable law, including, but not limited
6 to, the Financial Management Act of 1979. Except for those
7 funds appropriated under paragraphs (a), (b), (c), and (d)
8 of subsection (2) of section 2, subsection (3) of section 2,
9 subsection (5) of section 2 and paragraphs (a), (b),
10 (c), and (d) of subsection (6) of section 2, the allottee
11 shall be the Governor of the State of Truk. The allottee
12 for funds appropriated under paragraphs (a), (b), (c), and
13 (d) of subsection (2) of section 2 shall be the Northern
14 Namoneas Development Authority. The allottee for funds
15 appropriated under subsection (3) of section 2 shall be the
16 Southern Namoneas Development Authority. The allottees for
17 funds appropriated under subsection (5) of section 2 shall
18 be the respective development authorities of the Mortlock
19 Islands. The allottee for funds appropriated under
20 paragraph (a) of subsection (6) of section 2 shall be the
21 Pattiw Development Authority. The allottee for funds
22 appropriated under paragraph (b) of subsection (6) of
23 section 2 shall be the Weito Development Authority. The
24 allottee for funds appropriated under paragraphs (c) and (d)
25 of subsection (6) of section 2 shall be the Hall Islands

1 The allottees shall be responsible for ensuring that these
2 funds, or so much thereof as may be necessary, are used
3 solely for the purposes specified in this act, and that no
4 obligations are incurred in excess of the sum appropriated.
5 The authority of the allottees to obligate funds appro-
6 priated by this act shall remain effective until funds are
7 fully expended. The allottees shall make a written report
8 of the status of the funds appropriated hereunder to the
9 Congress of the Federated States of Micronesia during its
10 October regular session each year until such time as all
11 funds are fully expended."

12 Section 2. This act shall become law upon approval by the
13 President of the Federated States of Micronesia or upon its becoming
14 law without such approval.
