11	(5)(c), (5)(d), (5)(e), and (5)(f) of section 2 of this act shall be the Pohnpei Community							
12	Action Agency. The allottee of the funds appropriated under subsection (4) of section 2 of this act							
13	shall be the Mayor of Kolonia Town. The allottee of the funds appropriated under subsections							
14	of this set shall be the Chief Magistrate of Sokehs. The allottees							
15	shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are							
16	used solely for the purposes specified in this act, and that no obligations are incurred in excess of							
17	the sum appropriated. The authority of the allottees to obligate funds appropriated by this act							
	shall not lapse.
