A BILL FOR AN ACT

To amend Public Law No. 8-18 by amending section 9 to modify the designation of the source of funds for the College of Micronesia-FSM, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 9 of Public Law No. 8-18 is hereby amended to
2 read as follows:

3 "Section 9. College of Micronesia-FSM. The sum of
4 \$915,000, or so much thereof as may be necessary, is hereby
5 appropriated from the General Fund of the Federated States
6 of Micronesia for the fiscal year ending September 30, 1994,
7 to the College of Micronesia-FSM to defray costs associated
8 with the instruction of students and the operations and
9 maintenance of the College. ~~Such funds~~ Of such sum,
10 \$800,000 shall be deemed to come from funds available under
11 section 216(a)(3) of the Compact of Free Association."

12 Section 2. This act shall become law upon approval by the
13 President of the Federated States of Micronesia or upon its becoming
14 law without such approval.
