A BILL FOR AN ACT

To further amend title 55 of the Code of the Federated States of Micronesia, as amended, by amending sections 402, 403, 408 and 413 for the purpose of updating and expanding the applicability of the Public Contracts Act, and for other purposes.

BE	IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA
1	Section 1. Section 402 of title 55 of the Code of the
2	Federated States of Micronesia is hereby amended to read as
3	follows:
4	"Section 402. <u>Definitions</u> . As used in this chapter:
5	(1) 'Citizen bidder' means:
6	(a) nukil kng ketwinakion of kng traskeeship/
7	any business in which at least fifty-one petcent of the
8	interest therein is owned by a citizen or citizens of
9	the Trust Territory of the Pacific Islands;
10	(β <u>a)</u> υροή τετηϊηστίοη οτ της Ττηςτεσενίρ/ any
11	business in which at least fifty-one percent of the
12	interest therein is owned by a citizen or citizens of
13	the Federated States of Micronesia;
14	(c) nutil the tethination of the Trusteeship/ a
15	business which has been a resident of the Trust
16	Textitoty of the Pacific Islands for at least one year
17	immediately prior to the submission of its bid:
18	(db) upon tetmination of the Trusteeship/ a
19	business which has been a resident of the Federated
20	States of Micronesia for at least one year immediately
21	prior to the submission of its bid; and
22	(ec) upon termination of the Trusteeship/ a
23	business which has paid gross revenue taxes to the
24	Federated States of Micronesia for the one year period

immediately prior to the submission of its bid.

1	(2) 'Contracting officer' means the official in
2	charge of letting a contract for a Mational Government
3	agen¢y.
4	(3) 'Lowest responsible bidder' means the lowest
5	bidder whose offer adequately responds in quality,
6	fitness, and capacity to the particular requirements of
7	the proposed work called for by the contract.
8	(4) Ynational Govetnment agencyt means any btanch/
9	depattment/ office/ division/ boatd/ buteau/ commission/
10	committeel institution/ of anthofity of the national
11	Govetnment of the Fedetated States of Mictonesial"
12	Section 2. Section 403 of title 55 of the Code of the
13	Federated States of Micronesia is hereby amended to read as
14	follows:
15	"Section 403. Competitive bidding required. All
16	contracts for construction projects involving \$20,000 or
17	more of National Government funds or for the purchase of
18	personal property involving \$50,000 or more of National
19	Government funds made on behalf of any wational
20	Government agency shall be let by free and open
21	competitive bidding, by sealed bids, to the lowest
22	responsible bidder in accordance with the provisions of
23	this chapter."
24	Section 3. Section 408 of title 55 of the Code of the
25	Federated States of Micronesia is hereby amended to read as

1 follows: "Section 408. Emergencies. In case of emergency 2 affecting public health, safety, or convenience so 3 declared in writing by the President upon application by the contracting officer or his superior Mead of any 5 National Government agency setting forth the nature of the emergency and the danger to the public health, 7 safety, or convenience caused by delay, contracts may be 8 9 let to the extent necessary to meet the emergency 10 without public advertisement. Such action and the 11 reasons therefor shall immediately be made public by the 12 awarding authority." Section 4. Section 413 of title 55 of the Code of the 13 Federated States of Micronesia is hereby amended to read as 14 15 follows: 16 "Section 413. Award to lowest responsible bidder. 17 contracts shall be in writing and shall be executed by the <u>legal entity</u> National Government agency which is 18 authorized to let contracts in its own name and shall be 19 20 made with the lowest responsible bidder. If the lowest bid is rejected, the contracting officer may, at his 21 discretion, award the contract to the lowest remaining 22 responsible bidder or advertise anew for bids pursuant 23 24 to \$\delta \delta tion 412 of this chapter. In each instance the 25 officer, at his discretion, after determining the

1	lowest responsible bidder, may negotiate with that
2	bidder, and that bidder only, to reduce the scope of
3	work and to award the contract at a price which reflects
4	the reduction in the scope of work."
5	Section 5. This act shall become law upon approval by the
6	President of the Federated States of Micronesia or upon its
7	becoming law without such approval.
