A BILL FOR AN ACT

To further amend Public Law No. 6-91, as amended by Public Laws Nos. 6-103, 7-1 and 7-5, by further amending section 18, as amended by Public Law No. 7-1, to establish a lapse date for the authority to obligate certain funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 18 of Public Law No. 6-91, as amended by
2	Public Law No. 7-1, is hereby further amended to read as follows:
3	"Section 18. Allotment and management of funds and lapse
4	date. All funds appropriated by this act shall be allotted
5	managed, administered, and accounted for in accordance with
6	applicable law, including, but not limited to, the
7	Financial Management Act of 1979, as amended; PROVIDED,
8	however, that the allottees for funds appropriated under
9	paragraph (m) of subsection (2) of section 12 of this act
LO	shall be the Governors of the respective States and that
11	those funds shall not be disbursed from the General Fund to
12	the allottee unless the President certifies that the State
L3	involved has entered into a joint law enforcement agreement
L4	for the period of October 1, 1990 to September 30, 1991,
15	with the National Government pursuant to chapter 12 of
16	title 12 of the Code of the Federated States of Micronesia;
17	PROVIDED FURTHER, that the allottee of the funds appro-
18	priated under paragraph (h) of subsection (l) of section 12
19	of this act shall be the President, or his designee or
20	designees. Each allottee shall be responsible for ensuring
21	that these funds, or so much thereof as may be necessary,
22	are used solely for the purposes specified in this act, and
23	that no obligations are incurred in excess of the sum appro
24	priated. The authority of the allottees to obligate funds
25	appropriated by this act shall lapse as of September 30,

1	1991; PROVIDED, however, that the authority of the allottee
2	or his designees to obligate funds appropriated by
3	subsection (7) of section 2 of this act shall lapse as of
4	May 9, 1991; PROVIDED FURTHER, that the funds appropriated
5	under subsection (8) of section 2 of this act shall not be
6	allotted before May 10, 1991 and the authority of the
7	allottee or his designees to obligate the funds under such
8	subsection shall lapse as of May 9, 1992; PROVIDED FURTHER,
9	that the authority of the allottees to obligate funds
10	appropriated by sections 6, 9, 10, and $12(2)(p) \neq 1$
11	shall not lapse; and PROVIDED FURTHER, that the authority
12	of the allottees to obligate funds appropriated by section
13	13 shall lapse as of September 30, 1996."
14	Section 2. This act shall become law upon approval by the
15	President of the Federated States of Micronesia or upon its becoming
16	law without such approval.
