A BILL FOR AN ACT

To further amend Public Law No. 6-89, Kosrae State public projects, as amended, by amending section 3, as amended by Public Laws Nos. 7-7, 7-48, 7-51, 7-95 and 8-27, to modify the allottee of certain funds appropriated therein, and for other purposes

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 3 of Public Law No. 6-89, as amended by
2	Public Laws Nos. 7-7, 7-48, 7-51, 7-95 and 8-27, is hereby further amended to
3	read as follows:
4	"Section 3. All funds appropriated by this act shall be allotted,
5	managed, administered, and accounted for in accordance
6	with applicable law, including, but not limited to, the Financial
7	Management Act of 1979. The allottee of the funds
8	appropriated under subsection (1) of section 2 of this act shall
9	be the Chairman of the KSCIP. The allottee of the funds
10	appropriated under subsection (5) (g) and (5)(j) of section 2 of
11	this act shall be the FSM Revenue Representative in Kosrae.
12	The allottee of the all other funds appropriated under
13	subsection (5) of section 2 of this act shall be the Mayor of Utwe
14	Municipality. The allottee of the funds appropriated under
15	subsection (2) of section 2 of this act shall be the Mayor of
16	Lelu Municipality. The allottee of the funds appropriated
17	under subsection (3) of section 2 of this act shall be the
18	Mayor of Tafunsak Municipality. The allottee of the funds
19	appropriated under subsection (4) of section 2 of this act shall
20	be the Mayor of Malem Municipality. The allottee of the funds
21	appropriated under subsection (6) of section 2 of this act shall
22	be the Chairman of the Kosrae Congressional Delegation. The
23	allottees shall be responsible for ensuring that these funds, or so
24	much thereof as may be necessary, are used solely for the
25	purposes specified in this act, and that no obligations are

1	incurred in excess of the sum appropriated. The authority of
2	the allottees to obligate funds appropriated by this act shall
3	not lapse until expended."
4	Section 2. This act shall become law upon approval by the President
5	of the Federated States of Micronesia or upon its becoming law without such
6	approval.
