A BILL FOR AN ACT

To further amend Public Law No. 7-24, as amended, by further amending section 5, as amended by Public Laws Nos. 7-74, 7-84, 7-105, 8-40, and 8-119, for the purpose of changing the allottee of certain funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 7-24, as amended by Public
2 Laws Nos. 7-74, 7-84, 7-105, 8-40, and 8-119, is hereby further amended to
3 read as follows:

4 "Section 5. All funds appropriated by this act shall be
5 allotted, managed, administered, and accounted for in
6 accordance with applicable law, including, but not limited to,
7 the Financial Management Act of 1979. The allottee of the
8 funds appropriated under subsections (4), (6), (7), (8), (9),
9 (10), (11), (12), ~~and~~ (13), (14), (16) and (19) of section 1 of
10 this act and under subsections (1), (2), (3), (4), (5), (6),
11 (7), (8), and (9) of section 3 of this act shall be the
12 President of the Federated States of Micronesia. The allottee
13 of the funds appropriated under subsection (15) of section 1 of
14 this act shall be the Pohnpei Community Action Agency. The
15 allottee of the funds appropriated under subsection (1) of
16 section 2 of this act shall be the Meninkederlapalap of the
17 Municipality of Madolenihmw. The allottee of the funds
18 appropriated under subsection (2) of section 2 of this act
19 shall be the Lukenmoanlap of the Municipality of Kittu. The
20 allottees of the funds appropriated under section 2 of this act
21 shall submit detailed funds status and project status reports
22 to the Congress of the Federated States of Micronesia at the
23 beginning of each quarter of each fiscal year until the funds
24 appropriated thereunder are fully expended. The allottee of
25 the funds appropriated under section 4 of this act shall be the

1 Governor of Pohnpei State. The allottee of the funds
 2 appropriated under subsection (1) of section 1 of this act and
 3 subsection (10) of section 3 of this act shall be the Pohnpei
 4 State PTA. The allottee of the funds appropriated under
 5 subsection (2) of section 1 of this act shall be the Mayor of
 6 Kolonia Town. The allottee of the funds appropriated under
 7 subsections (3), (17) and (18) of section 1 of this act shall
 8 be the Chief Magistrate of Sokehs Municipality. ~~The allottees~~
 9 ~~of the funds appropriated under subsections (4)/ (14)/ (16) and~~
 10 ~~(19) of section 1 of this act and under subsections (1)/ (2)/~~
 11 ~~(3)/ (4)/ (5)/ (6)/ (7)/ (8) and (9) of section 3 of this act~~
 12 ~~shall be the Pohnpei Community Development Authority.~~ The allottee of
 13 the funds appropriated under subsection (5) of section 1 of
 14 this act shall be the Luhkenkolwof of Sapwuahfik Municipality.
 15 the allottee of the funds appropriated under subsection (11) of
 16 section 3 of this act shall be the Farmers Home Administration.
 17 The allottees shall be responsible for ensuring that these
 18 funds, or so much thereof as may be necessary, are used solely
 19 for the purposes specified in this act, and that no obligations
 20 are incurred in excess of the sum appropriated. The authority
 21 of the allottee of the funds appropriated under subsection (15)
 22 of section 1 of this act to obligate funds shall lapse as of
 23 September 30, 1994. The authority of all other allottees to
 24 obligate funds appropriated by this act shall not lapse."
