A BILL FOR AN ACT

To appropriate the sum of \$696,759 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for the purpose of funding the newly created National Election Office of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

, 1	Section 1. Operating expenses of the National Election Office. The			
2	sum of \$696,759, or so much thereof as may be necessary, is hereby			
3	appropriated from the General Fund of the Federated States of Micronesia			
4	for the fiscal year ending September 30, 1995, for the operation of the			
5	National Election Office. The sum appropriated under this section shall be			
6	apportioned as follows:

12	Section 2. Reprogramming. The allottee or his designee may			
13	reprogam up to 15 percent to and from the funds appropriated in each of			
14	the lines within the subsections of section 1.			
15	Section 3. Allotment and management of funds and lapse date. All			
16	funds appropriated by this act shall be allotted, managed, administered,			
17	and accounted for in accordance with applicable law, including, but not			
18	limited to, the Financial Management Act of 1979. The allottee for the funds			
19	apppropriated under section 1 of this act shall be the National Election			
20	Director of the Federated States of Micronesia or his designee. The allottee			
21	shall be responsible for ensuring that these funds, or so much thereof as			
22	may be necessary, are used solely for the purposes specified in this act, and			
23	that no obligations are incurred in excess of the sum appropriated. The			
24	authority of the allottee to obligate funds appropriated by this act shall			
25	lapse as of September 30, 1995.
