

AN ACT

PRESIDENTIAL COMM. NO. 8-48
FSM CONGRESS

To further amend Public Law No. 5-80, as amended, by further amending section 2, as amended by Public Laws Nos. 5-108, 6-34, 7-50, 7-65, 7-94 and 7-134, for the purpose of modifying the use of funds previously appropriated for public projects in Kosrae State, and by further amending section 3, as amended by Public Laws Nos. 6-34, 7-15, 7-52, and 7-94, for the purpose of changing the allottee of certain projects appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 5-80, as amended by
2 Public Laws Nos. 5-108, 6-34, 7-50, 7-65, 7-94 and 7-134, is hereby
3 further amended to read as follows:

21 Section 2. Section 3 of Public Law No. 5-80, as amended by
 22 Public Laws Nos. 6-34, 7-15, 7-52 and 7-94, is hereby further
 23 amended to read as follows:

24 "Section 3. All funds appropriated by this act shall be
 25 allotted, managed, administered, and accounted for in

1 accordance with applicable law, including, but not limited
2 to, the Financial Management Act of 1979. The allottee of
3 the funds appropriated under section 2 of this act shall be
4 the Governor of the State of Kosrae; except, however, that
5 the allottee of the funds appropriated under subsections
6 (1), (2), (3), (4)(a), (4)(b), (4)(c), (4)(d), (4)(e),
7 (4)(f), (4)(g), (4)(h), (4)(i), (5)(a), (5)(c), (5)(d),
8 (6), (7), (11) and (12) of section 2 of this act shall be
9 the Chairman of the Kosrae State Commission on Improvement
10 Projects, the allottee of the funds appropriated under
11 subsections (4)(j) and (4)(k) of section 2 of this act
12 shall be the Mayor of Malem Municipality, and that the
13 allottee of the funds appropriated under subsection (5)(b)
14 of section 2 of this act shall be the Mayor of Utwe
15 Municipality. Each allottee shall be responsible for
16 ensuring that these funds, or so much thereof as may be
17 necessary, are used solely for the purposes specified in
18 this act, and that no obligations are incurred in excess of
19 the sum appropriated. The authority of the allottees to
20 obligate funds appropriated by this act shall not lapse
21 until expended."

2 President of the Federated States of Micronesia or upon its becoming
3 law without such approval.


