## AN ACT

To appropriate the sum of \$519,400 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for the purpose of reappropriating certain funds which lapsed September 30, 1994, under Public Law No. 7-117, as amended, and for other purposes.

## BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. The sum of \$104,400, or so much thereo	f as may be	
2	necessary, is hereby appropriated from the General Fund of the Federated		
3	States of Micronesia for the fiscal year ending September 30, 1995, for the		
4	purpose of constructing and/or improving the Sokehs circumferential road and		
5	the Iohl road in Pohnpei State. The sum appropriated under this section shall be		
6	apportioned as follows:

9	Section 2. The sum of \$206,000, or so much thereo	f as may be	
10	necessary, is hereby appropriated from the General Fund of the Federated		
11	States of Micronesia for the fiscal year ending September 30, 1995, for the		
12	purpose of constructing and/or improving roads in the Kitti and Madolenihmw		
13	Municipalities in Pohnpei State. The sum appropriated under this section shall be		
14	apportioned as follows:

3	Section 3. The sum of \$209,000, or so much thereof as may be
4	necessary, is hereby appropriated from the General Fund of the Federated
5	States of Micronesia for the fiscal year ending September 30, 1995, for the
6	purpose of constructing and/or improving the Kahmar to Dolekei road.
7	Section 4. All funds appropriated by this act shall be allotted, managed,
8	administered, and accounted for in accordance with applicable law, including,
9	but not limited to, the Financial Management Act of 1979. The allottee of the
0 1	funds appropriated under section 1 of this act shall be the President of the
11	Federated States of Micronesia or the President's designee. The allottee of the
12	funds appropriated under subsection (1) of section 2 of this act shall be the
13	Chief Executive Officer of Madolenihmw Municipality, Pohnpei State. The allottee
14	of the funds appropriated under subsection (2) of section 2 of this act shall be
15	the Chief Executive Officer of Kitti Municipality, Pohnpei State. The allottee of
16	the funds appropriated under section 3 of this act shall be the Pohnpei
17	Transportation Authority. The allottees shall be responsible for ensuring that
18	these funds, or so much thereof as may be necessary, are used solely for the
19	purposes specified in this act, and that no obligations are incurred in excess of
20	the sum appropriated. The authority of the allottees to obligate funds
21	appropriated by this act shall not lapse.
