**Public Law No. 8 - 116**

ANACT

To further amend Public Law No. 8-75, as amended by Public Law No. 8-79, by further amending section 2, as amended by Public Law No. 8-79, to modify the use of funds; by further amending section 3, as amended by Public Law No. 8-79, to change the allottee of certain funds; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 8-75, as amended by Public Law No. 8-79,  
2 is hereby further amended to read as follows:

10 Section 2. Section 3 of Public Law No. 8-75, as amended by Public Law No. 8-79,  
11 is hereby further amended to read as follows:

12 "Section 3. All funds appropriated by this act shall be allotted, managed,  
13 administered, and accounted for in accordance with applicable law,  
14 including, but not limited to, the Financial Management Act of 1979. The  
15 allottee of the funds appropriated under subsection (1)(a) of section 2 of  
16 this act shall be the PWP Development Authority. The allottee of the funds  
17 appropriated under subsections (1)(b)(i), (1)(b)(ii), (1)(b)(iii) and  
18 (1)(b)(iv) of section 2 of this act shall be the Mayor of Fono. The allottee  
19 of the funds appropriated under subsections (1)(b)(v), (1)(b)(vi) and  
20 (1)(b)(vii) of section 2 of this act shall be the Mayor of Pis-Paneu. The  
21 allottee of the funds appropriated under subsections (1)(b)(viii),  
22 (1)(b)(x), (1)(b)(xi), and (1)(b)(xvii) of section 2 of this act shall  
23 be the Mayor of Weno. The allottee of the funds appropriated under  
24 subsections (1)(b)(ix), (1)(b)(xii), (1)(b)(xiii), (1)(b)(xiv),  
25 (1)(b)(xv), (1)(b)(xvi), and (1)(b)(xviii) of section 2 of this act

1 shall be the Weno Projects Coordinator. The allottee of the funds  
2 appropriated under subsection (1)(c) of section 2 of this act shall be the  
3 Southern Namoneas Development Authority. The allottee of the funds  
4 appropriated under subsection (1)(d) of section 2 of this act shall be the  
5 Lower Mortlocks Development Authority. The allottee of the funds  
6 appropriated under subsections (1)(e)(i), (1)(e)(ii) and (1)(e)(iii)  
7 of section 2 of this act shall be the Executive Director of the Hall  
8 Development Authority. The allottee of the funds appropriated under  
9 subsections (1)(e)(iv), (1)(e)(v) and (1)(e)(vi) of section 2 of this  
10 act shall be the Weito Development Authority. The allottee of the funds  
11 appropriated under subsections (1)(e)(vii), (1)(e)(viii), (1)(e)(ix),  
12 (1)(e)(x), (1)(e)(xi)a, (1)(e)(xi)b, (1)(e)(xii), and (1)(e)(xiii)  
13 of section 2 of this act shall be the Pattiw Development Authority. The  
14 allottee of the funds appropriated under subsections (1)(f)(i) and  
15 (1)(f)(ii) of section 2 of this act shall be the Executive Director of COCA.  
16 The allottee of the funds appropriated under subsections (1)(f)(iii),  
17 (1)(f)(iv) and (1)(f)(v) of section 2 of this act shall be the Governor of  
18 the State of Chuuk. The allottee of the funds appropriated under subsection  
19 (1)(f)(vi) of section 2 of this act shall be the Lower Mortlocks  
20 Development Authority. The allottee of the funds appropriated under  
21 subsection (2)(a)(i) of section 2 of this act shall be the Luhkenkolwof of  
22 Sapwuafik. The allottee of the funds appropriated under subsection  
23 (2)(a)(ii) of section 2 of this act shall be the Chief Magistrate of Nukuoro.  
24 The allottee of the funds appropriated under subsection (2)(a)(iii) of  
25 section 2 of this act shall be the Chief Magistrate of Kapingamarangi. The

1 allottee of the funds appropriated under subsection (2)(a)(iv) of section 2  
2 of this act shall be the Mayor of Kolonia Town. The allottee of the funds  
3 appropriated under subsections (2)(a)(v)a), (2)(a)(v)b) and 2(a)(v)i)  
4 of section 2 of this act shall be the Chief Magistrate of Sokehs. The allottee  
5 of the funds appropriated under subsections (2)(b), (2)(c), (2)(e),  
6 (2)(f), (4)(b), (4)(c), (4)(d), (4)(e), (4)(f), (4)(g), (4)(h),  
7 (4)(i), (4)(j) and (4)(k) of section 2 of this act shall be the President of  
8 the Federated States of Micronesia. The allottee of funds appropriated under  
9 subsection (2)(a)(v)c) of section 2 of this act shall be the Pohnpei  
10 Utility Corporation. The allottee of funds appropriated under subsection  
11 (2)(d) of section 2 of this act shall be the Pohnpei Transportation  
12 Authority. The allottee of the funds appropriated under subsection 3 of  
13 section 2 of this act shall be the Governor of the State of Yap or his designee.  
14 The allottee of the funds appropriated under subsection (4)(a) of section 2  
15 of this act shall be the Chairman of the Kosrae Sports Council. The allottee  
16 of the funds appropriated under subsections (4)(l) and (4)(n) of section 2  
17 of this act shall be the Mayor of the Lelu Municipal Government. The  
18 allottee of the funds appropriated under subsections (4)(m) and (4)(o) of  
19 section 2 of this act shall be the Mayor of the Malem Municipal Government.  
20 The allottee of the funds appropriated under subsection (4)(p) of section 2  
21 of this act shall be the Mayor of the Utwe Municipal Government. The  
22 allottee of the funds appropriated under subsection (4)(q) of section 2 of  
23 this act shall be the Mayor of the Tafunsak Municipal Government. The  
24 allottees shall be responsible for ensuring that these funds, or so much  
25 thereof as may be necessary, are used solely for the purposes specified in

1                   this act, and that no obligations are incurred in excess of the sum  
2                   appropriated. The authority of the allottees to obligate funds appropriated  
3                   by this act shall not lapse."

4                   Section 3. This act shall become law upon approval by the President of the Federated  
5 States of Micronesia or upon its becoming law without such approval.
