AN ACT

To further amend Public Law No. 4-17, as amended by Public Laws Nos. 4-47, 4-60, 7-62, and 8-31, Kosrae State public projects, by further amending section 3, as amended by Public Law No. 8-31, to modify the allottee of certain funds appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Secti	ion 1. Section 3 of Public Law No. 4-17, as amended by
2	Public Lav	w No. 8-31, is hereby further amended to read as follows:
3		"Section 3. All funds appropriated by this act shall be
4		allotted, managed, administered, and accounted for in
5		accordance with applicable law, including, but not limited
6		to, the Financial Management Act of 1979. The allottees
7		for appropriations under subsections (1) , (2) , (3) , and (4)
8		of section 2 shall be the Mayors of Lelu, Tafunsak, Malem,
9		and Utwe Municipalities, respectively. The allottee for
10		appropriations under subsections (5)(a), (c), (d), (e),
11		(f), (h), and (j) of section 2 shall be the Governor
12		of Kosrae State. The allottee for the funds appropriated
13		under subsection (5)(g) of section 2 shall be the Mayor of
14		Lelu. The allottee for the appropriation under subsection
15		(5)(b) of section 2 shall be the chairman of the Kosrae
16		congressional delegation. The allottee for the
17		appropriation under paragraph (5)(i) of section 2 shall be
18		the chairman of the Kosrae State Commission on Improvement
19		Projects. The allottees shall be responsible for ensuring
20		that these funds, or so much thereof as may be necessary,
21		are used solely for the purposes specified in this act, and
22		that no obligations are incurred in excess of the sum

1	appropriated. The authority of the allottees to obligate
2	funds appropriated by this act shall remain in effect until
3	all funds appropriated by this act are fully expended."
4	Section 2. This act shall become law upon approval by the
5	President of the Federated States of Micronesia or upon its becoming
6	law without such approval.
