Public Law No. 8 - 62

AN ACT

To further amend Public Law No. 5-89, as amended, by further amending section 5, as amended by Public Laws Nos. 5-99, 5-126, 6-8, 6-16 and 6-87, for the purpose of modifying the use of funds appropriated for public projects in the Mortlocks, Chuuk State, by further amending section 8, as amended by Public Laws Nos. 5-99, 7-2 and 7-56, for the purpose of changing the allottee of funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 5 of Public Law No. 5-89, as amended by Public Laws Nos. 5-99, 5-126, 6-8, 6-16 and 6-87, is hereby further 2 3 amended to read as follows: "Section 5. Mortlocks public projects. The sum of 4 \$350,000, or so much thereof as may be necessary, is hereby 5 appropriated from the General Fund of the Federated States 6 of Micronesia for the fiscal year ending September 30, 1989, 7 for the purpose of funding certain public projects in the 8 Mortlock Islands, Truk State. 14	"Section 8. Allotment and management of funds and	lapse
15	date. All funds appropriated by this act shall be	allotted,
16	managed, administered, and accounted for in accorda	nce with
17	applicable law, including, but not limited to, the	Financial
18	Management Act of 1979. The allottee of the funds	appropriate
19	under sections 1, 2 and 3 of this act shall be the	Governor of
20	Truk State, except for the funds appropriated by su	b-paragraph
21	(1)(d) of section 1 for which the allottee shall be	the Truk
22	State Congressional Delegation; by sub-paragraph (2) of section
23	1 for which the allottee shall be the Executive Dir	ector of
24	the Truk Maritime Authority; and by sub-paragraph (3) of
25	section 1 for which the allottee shall be the Execu	tive

Director of the Truk Organization of Community Action. The
allottee of the funds appropriated under sections 4 and 7 of
this act, under subsections (5) and (6) of section 5 of this
act, and under subsections $(4)(a)(i)$, $(4)(b)(i)$, $(4)(c)(i)$ and
(4)(d)(i) of section 6 of this act shall be the Chairman
of the Truk State Congressional Delegation. The allottee
of all other funds appropriated under section 5 of this act
shall be the Lower Mortlocks Development Authority. The
allottee of the funds appropriated under sub-paragraph (1)
and subsections (4)(a)(ii), (4)(b)(ii), (4)(c)(ii),
(4)(d)(ii), and $(4)(e)$ of section 6 of this act shall be the
Hall Islands Development Authority. The allottee of the
funds appropriated under sub-paragraphs (2) and (5) of
section 6 of this act shall be the Weito Islands Development
Authority. The allottee of the funds appropriated under
sub-paragraphs (3) and (6) of section 6 of this act shall be
the Pattiw Islands Development Authority. The allottee of
the funds appropriated under sub-paragraph (7) of section 6
of this act shall be the Board of Directors of the Nomwin
Co-op. Each allottee shall be responsible for ensuring that
these funds, or so much thereof as may be necessary, are used
solely for the purposes specified in this act, and that no
obligations are incurred in excess of the sum appropriated.
The authority of the allottees to obligate funds appropriated
by this act shall not lapse until expended."
