9	this act shall be the Mayor of Malem Municipality, the
10	allottee of the funds appropriated under subsection (5) of
11	section 2 of this act shall be the Mayor of Utwe

19	appropriated. The authority of the allottees to obligate
20	funds appropriated by this act shall not lapse until
21	expended."
