- WHEREAS, the Agreement Relating to the Implementation of 1
- Part XI of the United Nations Convention on the Law of the Sea
- of December 10, 1982 (hereinafter Part XI Agreement) was signed
- by the Federated States of Micronesia on August 10, 1994,
- subject to ratification by the Congress; and 5
- 6 WHEREAS, the Part XI Agreement implements Part XI of the
- 7 United Nations Convention on the Law of the Sea; and
- 8 WHEREAS, the Federated States of Micronesia acceded to the
- United Nations Convention on the Law of the Sea of December 10, 9
- 10 1982 (UNCLOS), on April 29, 1991; and
- WHEREAS, UNCLOS comes into force on November 16, 1994; and 11
- 12 WHEREAS, Part XI of UNCLOS relates to the resources at or
- beneath the seabed, and under UNCLOS the seabed and the subsoil 13
- beneath the seabed have been designated as "the common heritage 14
- of mankind"; and 15

- WHEREAS, PART XI and related provisions of UNCLOS establish 16
- a regime for the management and control of the seabed and ocean 17
- floor and the subsoil; and 18
- WHEREAS, the Part XI Agreement implements that regime by 19
- establishing a balanced control and a fair decision making 20
- mechanism in the management and use of the seabed area and its 21
- resources; and 22
- WHEREAS, ratification of the Part XI Agreement before 23
- November 16, 1994, is necessary in order to ensure that when \_ 24
  - UNCLOS comes into effect on that date, UNCLOS can be applied in 25

- 10 BE IT FURTHER RESOLVED that upon receipt of this resolution
- 11 by the President of the Federated States of Micronesia or the
- 12 Secretary of External Affairs shall lodge with the Secretary-
- 13 General of the United Nations as depository, an instrument of
- 14 ratification; and
- 15 BE IT FURTHER RESOLVED that a certified copy of this
- 16 resolution be transmitted to the President of the Federated
