15	responsible for ensuring that these funds, or so much thereof as may be
16	necessary, are used solely for the purposes specified in this act, and that no
17	obligations are incurred in excess of the sum appropriated. The authority of
18	the allottee to obligate funds appropriated by this act shall lapse as of
19	September 30, 1997.
