All funds appropriated by this act shall be allotted, managed, administered, and accounted for in accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. The allottee of the funds appropriated under subsection (1)(a) of section 2 of this act shall be the PWP Development Authority. The allottee of the funds appropriated under subsections (1)(b)(i), (1)(b)(ii), (1)(b)(iii) and (1)(b)(iv) of section 2 of this act shall be the Mayor of Fono. The allottee of the funds appropriated under subsections (1) (b)(v), (1)(b)(vi) and (1)(b)(vii) of section 2 of this act shall be the Mayor of Pis-Paneu. The allottee of the funds appropriated under subsections (1)(b)(viii), (1)(b)(x), (1)(b)(xi), and (1)(b)(xvii) of section 2 of this act shall be the Mayor of Weno. The allottee of funds appropriated under subsections (1)(b)(ix), (1)(b)(xii), (1)(b)(xiii). (1)(b)(xiv), (1)(b)(xv), (1)(b)(xvi), and (1)(b)(xviii) of section 2 of this act shall be the Weno Projects Coordinator.
