A BILL FOR AN ACT

To appropriate the sum of \$180,000 from the General fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for the purpose of funding the national government's cost-sharing portion of the United Nations Development Program's Micronesian Entrepreneur Development Centers project for the states of Yap, Chuuk, and Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$180,000, or so much thereof as may
- 2 be necessary, is hereby appropriated from the General Fund of
- 3 the Federated States of Micronesia for the fiscal year ending
- 4 September 30, 1995, for the purpose of funding the national
- 5 government's cost-sharing portion of the total initial cost of
- 6 the United Nations Development Program's Micronesian
- 7 Entrepreneur Development Centers project for the states of Yap,
- 8 Chuuk, and Kosrae.
- 9 Section 2. All funds appropriated by this act shall be
- 10 allotted, managed, administered, and accounted for in accordance
- 11 with applicable law, including, but not limited to, the
- 12 Financial Management Act of 1979. The allottee shall be the
- 13 President of the Federated States of Micronesia or his
- 14 designee(s). The allottee shall be responsible for ensuring
- 15 that these funds, or so much thereof as may be necessary, are
- 16 used solely for the purpose specified in this act, and that no
- 17 obligations are incurred in excess of the sum appropriated. The
- 18 authority of the allottee to obligate funds appropriated by this
- 19 act shall not lapse.
- 20 Section 3. This act shall become law upon approval by the
- 21 President of the Federated States of Micronesia or upon its
- 22 becoming law without such approval.

13	as may be necessary, are used solely for the purpose specified in this act, and		
14	that no obligations are incurred in excess of the sum appropriated. The		
15	authority of the allottee to obligate funds appropriated by this act shall not		
16	lapse.
