A BILL FOR AN ACT

To further amend Public Law No. 9-052, as amended by Public Laws Nos. 9-071, 9-086, 9-094, 9-108 and 9-117, by further amending section 3, as amended by Public Laws Nos. 9-086 and 9-117, and to amend Public Law No. 9-125 at section 2, to correct certain errors contained therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 3 of Public Law No. 9-052, as amended by Public Laws
2	Nos. 9-086 and 9-117, is hereby further amended to read as follows:
3	"Section 3. The sum of \$1,100,000, or so much" thereof as may be
4	necessary, is hereby appropriated from the General Fund of the
5	Federated States of Micronesia for the fiscal year ending September
6	30, 1996, for the purpose of capital improvements to the
7	transportation system, public projects and for other purposes in
8	Kosrae State. The funds appropriated under this section shall be
9	apportioned as follows:
10	(1) Road development and related
11	activities in Kosrae State \$ 370,000
12	(2) Office of the Governor: office
13	construction/renovation and landscaping 100,000
14	(3) Kosrae State Hospital: renovation and
15	maintenance/pharmaceuticals

10	Section 2. Section 2 of Public Law No. 9-125 is hereby amended to read as
11	follows:
12	"Section 2. All funds appropriated by this act shall be allotted,
13	managed, administered, and accounted for in accordance with
14	applicable law, including, but not limited to, the Financial Management
15	Act of 1979. The allottee of the funds appropriated herein shall be the
16	President of the Federated States of Micronesia or the President's
17	designee. The allottee shall be responsible for ensuring that these
18	funds, or so much thereof as may be necessary, are used solely for
19	the purpose specified in this act, and that no obligations are incurred in
20	excess of the sum appropriated. The authority of the allottee to
21	obligate funds appropriated by this act shall lapse as of September
22	30, 1988 <u>1998</u> ."
