## A BILL FOR AN ACT

To further amend Public Law No. 9-100, as amended by Public Laws Nos. 9-104, 9-129 and 9-137, by further amending section 3, as amended by Public Laws Nos. 9-104 and 9-137, to reduce the amount appropriated therein for Election District No. 1 of the State of Pohnpei by \$3,000, and to appropriate the sum of \$3,000 from the General Fund for the Federated States of Micronesia for the fiscal year ending September 30, 1997, for the purpose of funding emergency assistance to Nukuoro Island, State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 3 of Public Law No. 9-100, as amended
2	by Public Laws Nos. 9-104, and 9-137, is hereby further amended
3	to read as follows:
4	"Section 3. The sum of \$-4//356//000 4,347,000, or so
5	much thereof as may be necessary, is hereby appropriated
6	from the General Fund of the Federated States of
7	Micronesia for the fiscal year ending September 30,
8	1997, for the purpose of funding the infrastructure,
9	transportation, and tourism development needs of the
10	State of Pohnpei. The funds appropriated under this
11	section shall be apportioned as follows:
12	(1) To fund infrastructure development needs and
13	purchase and operation of equipment for transportation
14	needs
15	(a) District no. 1 \$ -PAY/PAY 897.000
16	(b) District no. 2
17	(i) Circumferential road 900,000
18	(ii) Other infrastructure
19	development needs
20	(c) District no. 3 800,000
21	(d) Asphalt patch plant 350,000
22	(2) Tourism development
23	(a) Pohnpei Visitor's Bureau
24	operation and promotional programs 250,000

1	and beautification programs \$250,000"
2	Section 2. The sum of \$3,000, or so much thereof as may be
3	necessary, is hereby appropriated from the General Fund of the
4	Federated States of Micronesia for the fiscal year ending
5	September 30, 1997, for the purpose of funding emergency
6	assistance to Nukuoro Island, State of Pohnpei.
7	Section 3. All funds appropriated by section 2 of this act
. 8	shall be allotted, managed, administered, and accounted for in
9	accordance with applicable law, including, but not limited to, the
10	Financial Management Act of 1979. The allottee of the funds
11	appropriated under this act shall be President of the Federated
12	States of Micronesia. The authority of the allottees to obligate
13	funds appropriated by section 2 of this act shall lapse as of
14	September 30, 1997.
15	Section 4. This act shall become law upon approval by
16	the President of the Federated States of Micronesia or upon its
17	becoming law without such approval.
