## A RESOLUTION

To transmit to the Speaker of the Congress, pursuant to section 104(1) of title 2 of the Code of the Federated States of Micronesia, the written declaration of the Members that the President is unable to discharge the powers and duties of his office, and to enable the Vice President thereupon to assume immediately the powers and duties of the President as Acting President.

- 1 WHEREAS, the President of the Federated States of
- 2 Micronesia, the Honorable Bailey Olter, has been and remains
- 3 hospitalized following a cerebral vascular accident that occurred
- 4 on July 16, 1996; and
- 5 WHEREAS, as a result of his condition and the symptoms of
- 6 his illness, the President is unable to discharge the powers and
- 7 duties of his office; and
- 8 WHEREAS, the Vice President cannot become the Acting
- 9 President without a declaration made pursuant to section 105(1) of
- 10 title 2 of the Code of the Federated States of Micronesia by a
- 11 majority of principal officers of the executive departments
- 12 appointed by the President under article X, section 2(d) of the
- 13 Constitution, or a declaration of two-thirds of the Congress
- 14 pursuant to section 104(1) of title 2 of the Code of the Federated
- 15 States of Micronesia; and
- 16 WHEREAS, the principal officers of the executive departments
- 17 have not transmitted the statutory declaration to the Speaker; and
- 18 WHEREAS, it is essential to the proper continued operation
- 19 of the National Government that the President's powers and duties
- 20 be exercised; and
- 21 WHEREAS, section 104(2) of title 2 of the Code of the
- 22 Federated States of Micronesia provides that the President shall
- 23 resume the powers and duties of his office upon his written
- 24 declaration that no inability exists, provided that Congress does
- 25 not transmit, within four days, a written declaration that the

President is unable to discharge the powers and duties of his 1 2 office; now therefore, BE IT RESOLVED by the Ninth Congress of the Federated States 3 of Micronesia, Fourth Regular Session, 1996, that a declaration made pursuant to section 104(1) of title 2 of the Code of the Federated States of Micronesia, stating the foregoing and bearing 6 the signatures of no less than two-thirds of the Members of 7 Congress, be transmitted to the Speaker upon adoption of this 8 9 resolution; and BE IT FURTHER RESOLVED that certified copies of this 10 resolution be transmitted to the President and the Vice President 11 of the Federated States of Micronesia and to the Chief Justice of 12 the Supreme Court, and the principal executive officers of the 13 executive branch appointed by the President pursal ant to article X, 14 15 section 2(d). 16 Date: Nov. 8, 1996 Introduced by: Christian 17 18 Isaac V Figir 19 20 Rosevelt 21 22 laude H.
