A RESOLUTION

To ratify the Stamps and Philatelic Agency Agreement Between the Federated States of Micronesia and the Inter-Governmental Philatelic Corporation.

WHEREAS, the Federated States of Micronesia, as a sovereign 1 and independent nation, has the need to provide its Postal 2 Service with necessary and suitable supplies of postage stamps 3 for use in evidencing the prepayment of fees and services for 4 the carriage of Federated States of Micronesia's mails; and 5 WHEREAS, the Federated States of Micronesia recognizes that 6 the issuance of postage stamps is a unique and effective way of 7 focusing attention on the Federated States of Micronesia's 8 history and culture and of creating a greater world-wide 9 awareness of the Federated States of Micronesia; and 10 WHEREAS, the Federated States of Micronesia believes that 11 in satisfying the legitimate needs and interests of stamp 12 collectors around the world who wish to obtain the postage 13 stamps, the Federated States of Micronesia has the opportunity 14 to create additional revenue which will benefit the Federated 15 States of Micronesia and, in particular, will support and make 16 possible the further extension and modernization of the 17 Federated States of Micronesia's postal services; and 18 WHEREAS, the Federated States of Micronesia desires to 19 engage the services of a qualified distributor to manage, 20 design, produce, promote, sell and distribute new postage stamps 21 of the Federated States of Micronesia and to provide the 22 Federated States of Micronesia with technical assistance; and 23 WHEREAS, Inter-Governmental Philatelic Corporation has the 24

necessary knowledge and expertise, and wishes to undertake to

2	stamps of the Federated States of Micronesia throughout the
3	world and to provide the Federated States of Micronesia with
4	technical assistance; now, therefore,
5	BE IT RESOLVED by the Ninth Congress of the Federated
6	States of Micronesia, Fifth Special Session, 1997, that pursuant
7	to section 110 of title 39 of the Code of the Federated States
8	of Micronesia, the Congress hereby ratifies the Stamps and
9	Philatelic Agency Agreement between the Federated States of
10	Micronesia and the Inter-Governmental Philatelic Corporation;

14	States of Micronesia, the Postmaster General of the Federated
