### AN ACT

To further amend section 1208 of title 55 of the Code of the Federated States of Micronesia (Annotated), as enacted by Public Law No. 10-150 and as amended by Public Law No. 18-74, to change the composition and manner of appointment and recall of the Board of Trustees of the FSM Trust Fund, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 1208 of title 55 of the Code of the
- 2 Federated States of Micronesia (Annotated), as amended by Public
- 3 Law No. 18-74, is hereby further amended to read as follows:
- 4 "Section 1208. Board.
- (1) The Fund shall have a Board of Trustees consisting 5 of five trustees. One of these trustees shall be the 6 Secretary of Finance and Administration, who shall serve as 7 an ex officio member of the Board. The remaining four 8 trustees shall be appointed by the President of the 9 Federated States of Micronesia with the advice and consent 10 of Congress. The minimum qualification for services as a 11 member of the Board shall be a bachelor's degree in finance 12 or a related field, and five years of experience in the 13 area of finance. Board members shall serve a term of four 14

years. The President of the Federated States of Micronesia

may recall appointees to the Board. The Board shall elect

18 (2) All powers of the Fund shall be vested in and

a Chairman from amongst its members.

2	(3) The functions of the Board shall include:		
3	(a) obtaining, along with others, contributions to		
4	the Fund;		
5	(b) operation, supervision and management of the		
6	Fund; and		
7	(c) investment and distribution of resources of the		
8	Fund.		
9	(4) Trustees shall serve as such without payment of		
10	compensation from the Fund or any other source. Reasonable		
11	expenses of the Board itself shall be provided for annually		
12	in the national budget of the FSM and not paid out of the		
13	Fund.		
14	(5) The Board shall meet at least once per year and		
15	additionally as necessary, and reasonable notice shall be		
16	given of meetings.		
17	(6) For the purposes of meetings of the Board, three-		
18	fifths of trustees shall constitute a quorum.		
19	(7) Except where otherwise provided in this chapter,		
20	questions before the Board shall be decided by a majority		
21	of votes of trustees present and voting at the meeting.		
22	(8) The Board shall establish its own bylaws and rules of		
23	procedure.		
24	(9)All expenses of the Board shall be subject to

1	Fund under section 1212."			
2		Section 2.	This act shall become law upon approval by	
3	the	President of	the Federated States of Micronesia or upon	
4	its	becoming law	without such approval.
