

A BILL FOR AN ACT

To further amend Public Law No. 18-11, as amended by Public Law No. 18-44, by amending section 1 thereof, to change to use of funds previously appropriated therein for the State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 18-11, as amended
2 by Public Law No. 18-44, is hereby further amended to read as
3 follows:

4 "Section 1. The sum of \$1,680,000, or so much thereof
5 as may be necessary, is hereby appropriated from the
6 General Fund of the Federated States of Micronesia for
7 the fiscal year ending September 30, 2013, to assist the
8 States of Pohnpei and Yap in retiring debt and covering
9 budget shortfalls, providing funding for the Micronesia
10 Legal Services Corporation, purchase of an asphalt plan
11 and road paving equipment and materials; PROVIDED THAT
12 the funds appropriated shall not be used for personnel
13 and travel expenses. The funds shall be apportioned as
14 follows:

15 1. Pohnpei State.....\$ 1,130,000

16 PROVIDED HOWEVER, that the funds appropriated in
17 subsections (b) (c) (d) and (e) of this section shall not
18 be allotted until Congress is officially advised that
19 funds improperly disbursed as a result of the line item

1 veto which was reflected in Public Law No. 18-11 are
 2 collected.
