

A BILL FOR AN ACT

To appropriate the sum of \$2,100,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2015, for the purpose of funding public projects and social programs in the States of Yap, Kosrae, Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Purpose. The sum of \$2,100,000, or so much
2 thereof as may be necessary, is hereby appropriated from the
3 General Fund of the Federated States of Micronesia for the fiscal
4 year ending September 30, 2015, for the purpose funding public
5 projects and social programs in the States of Yap, Kosrae, Pohnpei
6 and Chuuk. The funds appropriated under this section shall be
7 apportioned as follows:

8 Section 2. Of the sum of \$2,100,000 appropriated by this
9 act, \$300,000 is apportioned for public projects and social
10 programs in the State of Yap.

12 Section 3. Of the sum of \$2,100,000 appropriated by this
13 act, \$300,000 is apportioned for public projects and social
14 programs in the State of Kosrae.

16 Section 4. Of the sum of \$2,100,000 appropriated by this
17 act, \$600,000 is apportioned for public projects and social
18 programs in the State of Pohnpei.

6 Section 5. Of the sum of \$2,100,000 appropriated by this
 7 act, \$900,000 is apportioned for public projects and social
 8 programs in the State of Chuuk.

16 Section 6. Allotment and management of funds and lapse
 17 date. All funds appropriated by this act shall be allotted,
 18 managed, administered and accounted for in accordance with
 19 applicable laws, including, but not limited to, the Financial
 20 Management Act of 1979. The allottee shall be responsible for
 21 ensuring that these funds, or so much thereof as may be
 22 necessary, are used solely for the purpose specified in this
 23 act, and that no obligations are incurred in excess of the sum
 24 appropriated. The allottee of the funds appropriated under
 25 section 2 of this act shall be the Governor of Yap State. The

1 allottee of funds appropriated under sections 3 and 4 of this
2 act shall be the President of the Federated States of
3 Micronesia or his designee. The allottee of funds appropriated
4 under subsections 5(1), 5(3) and 5(6) of this act shall be the
5 Governor of Chuuk State or his designee. The allottee of funds
6 appropriated under subsection 5(2) of this act shall be the
7 Mortlock Islands Development Authority. The allottee of funds
8 appropriated under subsection 5(4) of this act shall be the
9 Southern Namoneas Development Authority. The allottee of funds
10 appropriated under subsection 5(5) of this act shall be the
11 Faichuk Development Authority. The authority of the allottee to
12 obligate funds appropriated by this act shall lapse on
13 September 30, 2017.

14 Section 7. This act shall become law upon approval by the
15 President of the Federated States of Micronesia or upon its
16 becoming law without such approval.
