A BILL FOR AN ACT

To further amend Public Law No. 18-11, as amended by Public Laws Nos. 18-44, 18-81, 19-33, 19-106, 19-128, 19-134, 19-138 and 20-11, by amending section 2 thereof, to change the allottee of funds previously appropriated for public projects and social programs in the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1           Section 1. Section 2 of Public Law No. 18-11, as amended  
2 by 18-44, 18-81, 19-33, 19-128, 19-138 and 20-11, is hereby  
3 further amended to read as follows:

4           "Section 2. Allotment and management of funds and  
5 lapse date. All funds appropriated by this act shall  
6 be allotted, managed, administered and accounted for  
7 in accordance with applicable laws, including, but not  
8 limited to, the Financial Management Act of 1979. The  
9 allottee shall be responsible for ensuring that these  
10 funds, or so much thereof as may be necessary, are  
11 used solely for the purpose specified in this act, and  
12 that no obligations are incurred in excess of the sum  
13 appropriated. The allottee of the funds appropriated  
14 under subsection 1 of section 1 of this act shall be  
15 the President of the Federated States of Micronesia or  
16 his designee; PROVIDED THAT, the allottee of funds  
17 appropriated under subsection[s] 1(b)(vi) [~~1(d)(i) and~~  
18 ~~1(d)(ii) 1(d)(iii)] of this act shall be the Pohnpei~~

1           Transportation Authority (PTA); the allottee of funds  
2           appropriated under subsection 1(b)(v) of this act  
3           shall be the Governor of the State of Pohnpei or his  
4           designee; the allotte of funds appropriated under  
5           subsections 1(b)(i), 1(b)(ii), 1(b)(iii) 1(b)(vii),  
6           ~~[and]~~ ~~1[~~b~~](b)(viii)~~, 1(d)(i), 1(d)(ii), 1(d)(iii) and  
7           1(d)(iv) shall be the Secretary of the Department of  
8           Transportation, Communications and Infrastructure or  
9           his designee. The allottee of funds appropriated  
10          under subsection 2 of section 1 of this act shall be  
11          the Governor of the State of Yap or his designee. The  
12          authority of the allottee to obligate funds  
13          appropriated by this act shall lapse on September 30,  
14          2018."

15          Section 2. This act shall become law upon approval by the  
16          President of the Federated States of Micronesia or upon its  
17          becoming law without such approval.
