

AN ACT

To further amend Public Law No. 17-36, as amended by Public Laws Nos. 17-48, 17-78, 17-87, 18-36, 18-60, 18-65, 18-84, 19-22, 19-109, 20-17, 21-18, 21-124, 21-161, 22-126 and 22-165, by amending sections 3 and 6 thereof, to change the use and extend the lapse date of certain funds previously appropriated therein, to fund public projects and social programs in each of the states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1           Section 1.   Section 3 of Public Law No. 17-36, as amended  
2 by Public Laws Nos. 17-48 and 22-165, is hereby further amended  
3 to read as follows:

4           "Section 3.  Of the sum of \$2,100,000 appropriated by  
5 this act, \$300,000 is apportioned for Kosrae State for  
6 public projects and social programs.

8           (1) At- Large.....           200,000

9                   (a) Kosrae State subsidy for renovations and  
10 maintenance of Kosrae State Government buildings,  
11 community primary and secondary roads, sport facilities  
12 and water systems, PROVIDED that the funds shall be used  
13 as matching for Infrastructure Maintenance Fund       125,000

14                   (b) Subsidy for four municipal  
15 governments.....           40,000

18 Section 2. Section 6 of Public Law No. 17-36, as amended  
 19 by Public Laws Nos. 17-48, 17-78, 17-87, 18-36, 18-65, 18-84,  
 20 19-22, 19-109, 20-17, 21-18, 21-124, 21-161 and 22-126, is  
 21 hereby further amended to read as follows:

22 "Section 6. Allotment and management of funds and  
 23 lapse date. All funds appropriated by this act shall  
 24 be allotted, managed, administered and accounted for in  
 25 accordance with applicable laws, including, but not

1           limited to, the Financial Management Act of 1979. The  
2           allottee shall be responsible for ensuring that these  
3           funds, or so much thereof as may be necessary, are used  
4           solely for the purpose specified in this act, and that  
5           no obligations are incurred in excess of the sum  
6           appropriated. The allottee of the funds appropriated  
7           under Section 2 of this act shall be the Governor of  
8           Yap State. The allottee of funds appropriated under  
9           section 3 of this act shall be the Mayor of Lelu Town  
10          Government or his designee. The allottee of funds  
11          appropriated in section 4 of this act shall be the  
12          President of the Federated States of Micronesia or his  
13          designee; EXCEPT THAT, the allottee of funds  
14          appropriated under subsection 4(1)(b), 4(3)(a) and (b)  
15          of section 4 of this act shall be the Pohnpei  
16          Transportation Authority. The allottee of funds  
17          appropriated under subsection 4(2)(j) of section 4  
18          shall be the Chief Magistrate of Sokehs Municipal  
19          Government. The allottee of funds appropriated under  
20          subsections 5(1) and 5(6) of section 5 of this act  
21          shall be the Governor of Chuuk State or his designee.  
22          The allottee of funds appropriated under subsection  
23          5(2) of section 5 of this act shall be the Mortlock  
24          Islands Development Authority; the allottee of funds  
25          appropriated under subsection 5(3) of section 5 of this

1           act shall be the Mayor of Weno Municipal Government or  
2           his designee; the allottee of funds appropriated under  
3           subsection 5(4) of section 5 of this act shall be the  
4           Southern Namoneas Development Authority. The allottee  
5           of funds appropriated under subsection 5(5) of section  
6           5 of this act shall be the Faichuk Development  
7           Authority. The allottee of funds appropriated under  
8           subsection 5(6)(f) shall be the President of COM-FSM.  
9           The authority of the allottee to obligate funds  
10          appropriated by this act shall lapse on September 30,  
11          2026.”

12          Section 3. This act shall become law upon approval by the  
13          President of the Federated States of Micronesia or upon its  
14          becoming law without such approval.
