

AN ACT

To further amend Public Law No. 21-80, as amended by Public Laws Nos. 21-99, 21-110, 21-143, 21-181, 21-188, 21-214 and 21-242, by amending sections 4 and 6 thereof, to change the use and allottee of certain funds previously appropriated therein, to fund public projects and social programs for the people of Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 21-80, as amended by  
2 Public Laws Nos. 21-143 and 21-181, is hereby further amended to  
3 read as follows:

4 "Section 4. Of the \$4,200,000 appropriated under this  
5 act, \$1,200,000 shall be apportioned for public projects  
6 and social programs for the people of Pohnpei State.

20 Section 2. Section 6 of Public Law No. 21-80, as amended by  
 21 Public Laws Nos. 21-99, 21-110, 21-143 and 21-181, is hereby  
 22 further amended to read as follows:

23 "Section 6. Allotment and management of funds and lapse  
 24 date. All funds appropriated by this act shall be  
 25 allotted, managed, administered and accounted for in

1           accordance with applicable laws, including, but not  
2           limited to, the Financial Management Act of 1979. The  
3           allottee shall be responsible for ensuring that these  
4           funds, or so much thereof as may be necessary, are used  
5           solely for the purpose specified in this act, and that  
6           no obligations are incurred in excess of the sum  
7           appropriated. The allottee of the funds appropriated  
8           under section 2 of this act shall be the Governor of Yap  
9           State or his designee; PROVIDED THAT, the allottee of  
10          funds appropriated under subsection 2(a) of this act  
11          shall be the President of COM-FSM; the allottee of funds  
12          appropriated under subsections 2(c) and 2(d) of this act  
13          shall be the President of the Federated States of  
14          Micronesia or his designee. The allottee of funds  
15          appropriated under sections 3 and 4 of this act shall be  
16          the President of the Federated States of Micronesia or  
17          his designee; PROVIDED THAT, the allottee of funds  
18          appropriated under subsection 3(1) of this act shall be  
19          the Governor of Kosrae State or his designee; the  
20          allottee of funds appropriated under subsection 3(2) of  
21          this act shall be the Mayor of Lelu Town Government or  
22          his designee; the allottee of funds appropriated under  
23          subsections 4(2) of this act shall be the Secretary of  
24          the Department of Transportation, Communications and  
25          Infrastructure, except that the allottee funds

1           appropriated under subsection 4(2)(f) shall be the  
2           Pohnpei Port Authority (PPA); the allottee of funds  
3           appropriated under subsections 4(3)(a), 4(3)(1) and  
4           4(3)(m) of this act shall be the Pohnpei Transportation  
5           Authority (PTA); the allottee of funds appropriated  
6           under subsections 4(3)(b) and 4(3)(c) of this act shall  
7           be the Luhkenmoanlap of Kitti; the allottee of funds  
8           appropriated under subsections 4(3)(e), 4(3)(f), 4(3)(g)  
9           and 4(3)(o) of this act shall be the Meninkeder of  
10          Madolenihmw; the allottee of funds appropriated under  
11          subsections 4(3)(i) and 4(3)(j) of this act shall be the  
12          Secretary of the Department of Health and Social Affairs  
13          or his designee; the allottee of funds appropriated  
14          under subsection 4(3)(h) of this act shall be the  
15          Director of COM Land Grant Program or his designee; the  
16          allottee of funds appropriated under subsection 4(3)(n)  
17          of this act shall be the Vice President of the Federated  
18          States of Micronesia or his designee. The allottee of  
19          the funds appropriated under subsections 5(1) and 5(6)  
20          of this act shall be the Governor of Chuuk State or his  
21          designee; the allottee of the funds appropriated under  
22          subsection 5(2) of this act shall be the Mortlocks  
23          Island Development Authority (MIDA); the allottee of  
24          funds appropriated under subsection 5(3) of this act  
25          shall be the Mayor of Weno Municipal Government or his

1           designee; the allottee of the funds appropriated under  
2           subsection 5(4) of this act shall be the Southern  
3           Namoneas Development Authority; the allottee of the  
4           funds appropriated under subsection 5(5) of this act  
5           shall be the Faichuk Development Authority. The  
6           authority of the allottee to obligate funds appropriated  
7           by this act shall lapse on September 30, 2022.”

8           Section 3. This act shall become law upon approval by the  
9           President of the Federated States of Micronesia or upon its  
10          becoming law without such approval.
