

A BILL FOR AN ACT

To appropriate the sum of \$2,800,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2012, for the purpose of funding public projects and social programs in the States of Yap, Kosrae, Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$2,800,000, or so much thereof as
2 may be necessary, is hereby appropriated from the General Fund
3 of the Federated States of Micronesia for the fiscal year
4 ending September 30, 2012, for the purpose of funding public
5 projects and social programs in the States of Yap, Kosrae,
6 Pohnpei and Chuuk. The funds appropriated under this section
7 shall be apportioned as follows:

8 Section 2. Of the sum of \$2,800,000 appropriated by this
9 act, \$400,000 is apportioned for Yap State for public projects
10 and social programs.

11 State of Yap.....\$ 400,000

12 Section 3. Of the sum of \$2,800,000 appropriated by this
13 act, \$400,000 is apportioned for Kosrae State for public
14 projects and social programs.

15 State of Kosrae..... 400,000

16 Section 4. Of the sum of \$2,800,000 appropriated by this
17 act, \$800,000 is apportioned for Pohnpei State for public
18 projects and social programs.

6 Section 5. Of the sum of \$2,800,000 appropriated by this
7 act, \$1,200,000 is apportioned for Chuuk State for public
8 projects and social programs.

16 Section 6. Allotment and management of funds and lapse
17 date. All funds appropriated by this act shall be allotted,
18 managed, administered and accounted for in accordance with
19 applicable laws, including, but not limited to, the Financial
20 Management Act of 1979. The allottee shall be responsible for
21 ensuring that these funds, or so much thereof as may be
22 necessary, are used solely for the purpose specified in this
23 act, and that no obligations are incurred in excess of the sum
24 appropriated. The allottee of the funds appropriated under
25 section 2 of this act shall be the Governor of Yap State. The

1 allottee of funds appropriated under sections 3 and 4 of this
2 act shall be the President of the Federated States of
3 Micronesia or his designee. The allottee of funds appropriated
4 under subsections 5(1) and 5(6) of this act shall be the
5 Governor of Chuuk State or his designee. The allottee of funds
6 appropriated under subsection 5(2) of section 5 of this act
7 shall be the Mortlock Islands Development Authority. The
8 allottee of funds appropriated under subsection 5(3) of section
9 5 of this act shall be the Executive Director of the Northern
10 Namoneas Social and Economic Development Authority or his
11 designee. The allottee of funds appropriated under subsection
12 5(4) of section 5 of this act shall be the Faichuk Development
13 Authority. The allottee of funds appropriated under subsection
14 5(5) of section 5 of this act shall be the Southern Namoneas
15 Development Authority. The authority of the allottee to
16 obligate funds appropriated by this act shall lapse on
17 September 30, 2014.

18 Section 7. This act shall become law upon approval by the
19 President of the Federated States of Micronesia or upon its
20 becoming law without such approval.
