

A BILL FOR AN ACT

To further amend Public Law No. 15-32, as amended by Public Laws Nos. 15-36, 15-44, 15-57, 15-63, 15-72, 15-78, 16-03, 16-11, 16-33 and 16-46, by amending section 1 thereof, to change the use of certain funds previously appropriated therein for the State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 15-32, as
2 amended by Public Laws Nos. 15-36, 15-44, 15-57, 15-63,
3 15-72, 15-78, 16-03, 16-11, 16-33 and 16-46 is hereby
4 further amended to read as follows:

5 "Section 1. The sum of \$3,780,000, or so much
6 thereof, is hereby appropriated from the General
7 Fund of the Federated States of Micronesia for the
8 fiscal year ending September 30, 2008, for the
9 purpose of funding public projects and social
10 programs in each State of the Federated States of
11 Micronesia. The fund shall be apportioned on the
12 basis of \$250,000 or less per member of Congress
13 as follows, PROVIDED THAT an increase of \$300,000
14 is for Yap State.
