

FIRST CONGRESS OF THE FEDERATED STATES OF MICRONESIA

SECOND SPECIAL SESSION, 1980

CONGRESSIONAL BILL NO. 1-199, C.D. 1

AN ACT

To appropriate the sum of \$315,100 from the General Fund of the Federated States of Micronesia to supplement funds appropriated by Public Laws No. 1-21 and No. 1-52 for the Annual Budget of the Government of the Federated States of Micronesia for the fiscal year ending September 30, 1980; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Executive, Judiciary and Public Auditor Operations.

2 (1) The sum of \$310,100 or so much thereof as may be necessary, is
3 hereby appropriated from the General Fund of the Federated States of Micronesia
4 to supplement funds appropriated by Public Laws No. 1-21 and 1-52 for the
5 operational expenses of the Government of the Federated States of Micronesia.
6 The sum herein appropriated shall be distributed as follows:

7 (a) Offices of the President and Vice President:

8 (1) Salaries and Benefits \$ 45,600

9 (2) Travel for Executive Branch 43,000

10 (b) Executive Branch Operations. 120,000

11 (c) Executive Branch Incidental Expenses 13,900

12 (d) National Judiciary 44,000

13 (e) Public Auditor 22,200

14 (f) Washington LNO Office. 21,400

15 (2) The President may authorize expenditures not to exceed ten
16 percent of line items (a), (b), and (c) in this section; provided, however,
17 that the total obligations incurred shall not exceed the sum appropriated by
18 said line item.

19 Section 2. Coconut Processing. The sum of \$5,000, or so much thereof
20 as may be necessary, is hereby appropriated from the General Fund of the
21 Federated States of Micronesia for the operations of the Micronesian Coconut
22 Processing Authority.

1 Section 3. Administration of Funds. Funds appropriated by this act
2 shall be administered in accordance with Public Law No. 1-45. Any sum
3 remaining unobligated as of September 30, 1980 shall revert to the General
4 Fund of the Federated States of Micronesia.

5 Section 4. Repealer. Section 5 of Public Law No. 1-52 is hereby
6 repealed in its entirety.

7 Section 5. Funds from Other Sources. The Congress may by resolution
8 authorize the expenditures of such sums as may be available, after the
9 effective date of this act, from sources other than the General Fund of the
10 Federated States of Micronesia, including grants from the United States
11 Government, for the operations and contingent expenses of the Federated States
12 of Micronesia Government, including the creation of positions in addition to
13 those stated in Section 4 of Public Law 1-52, subject to the terms of the
14 grant or other source. No such expenditure shall otherwise be made; PROVIDED,
15 FURTHER, that the appropriate Committee of the Congress shall have authority
16 to approve such expenditure if Congress is not in session.

17 Section 6. Effective Date. This act shall take effect upon approval
18 by the President of the Federated States of Micronesia, or upon its becoming
19 law without such approval.
