

AN ACT

To authorize and appropriate the sum of \$458,500 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1982, for the purpose of funding public projects in the State of Ponape, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Appropriation. The sum of \$458,500, or so much thereof
2 as may be necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending September 30,
4 1982, for the purpose of funding public projects in the State of Ponape.

5 The sum appropriated shall be apportioned in the following manner:

6 (1) Kitti Municipality for transportation, infrastructure, and
7 farmers' aid

8 (a) Transportation equipment. \$15,000

9 (b) Channels, farm roads, classrooms, school supplies,
10 economic development projects assistance, and summer training. . .20,000

11 (2) Madolenihmw Municipality for transportation,
12 infrastructure, and farmers' aid

13 (a) Economic development projects, classrooms, farm
14 roads, causeway, and summer training 20,000

15 (b) Sapwerehk elementary classrooms. 9,000

16 (c) Nansohli water system. 1,000

17 (d) Diadi water system. 1,000

18 (e) Kitamw water system. 1,000

19 (f) Lohd Pah water system 1,000

20 (g) Lohd Powe bridge. 1,000

21 (h) Dispensary water system. 1,000

10 (8) Ponape State for the start-up and acquisition of material
11 for the construction of the Ponape Marine Railroad, a drydocking facility
12 that will handle ships at least the size of micro-class vessels. This
13 amount may be supplemented by future appropriations of the Federated States
14 of Micronesia Congress, the Ponape State Legislature, applicable United
15 States grant(s), applicable foreign aid(s) to the Federated States of Micro-
16 nesia, or private contributions. 165,000

17 (9) Boat and motors for Dental Mobile Team and related
18 expenses. 5,000

19 Section 2. Project execution. The chief magistrate of such respective
20 municipality or township, with necessary aid from the Governor's Office,
21 shall have primary responsibility as to design specifications, material,
22 labor costs, work schedule, and public bidding on projects. The Ponape
23 State Governor, or his designee, shall review and approve each plan to insure
24 against over expenditure, and shall conduct field inspections to insure
25 project specifications, work schedule compliance, and over-all quality

1 control. The Governor, or his designee, shall insure performance payment
2 schedules and maintain accurate records of expenditures of each project.

3 Section 3. Annual report. An annual report of all project expend-
4 itures, completed or not, shall be submitted to the Federated States of
5 Micronesia Finance Director, who shall make the same available to the
6 Federated States of Micronesia Congress.

7 Section 4. Reversion. Funds unexpended at the end of fiscal year
8 September 1983 shall revert to the General Fund of the Federated States of
9 Micronesia.

10 Section 5. Effective date. This act shall become law upon approval
11 by the President of the Federated States of Micronesia or upon its
12 becoming law without such approval.
