CONGRESSIONAL BILL NO. 3-262

AN ACT

To further amend Public Law No. 2-34, as amended by Public Laws Nos. 2-44, 3-12, 3-17, and 3-35, which appropriated funds for public projects in Truk State, by amending sections 1 and 3 to reallocate funds and extend the reversion date, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 2-34, as amended by
2 Public Laws No. 2-44, 3-12, and 3-35, is hereby further amended
3 to read as follows:

4 "Section 1. The sum of \$846,200, or so much thereof as
5 may be necessary, is hereby appropriated from the General
6 Fund of the Federated States of Micronesia for the fiscal
7 year ending September 30, 1982, for the purpose of funding
8 certain public projects in the State of Truk. The sum
9 appropriated by this section shall be apportioned as
10 follows:


1 read as follows:

2 "Section 3. All funds appropriated by this act shall
3 be allotted, managed, administered, and accounted for
4 in accordance with applicable law, including, but not
5 limited to, the Financial Management Act of 1979. The
6 allottee shall be responsible for ensuring that these
7 funds, or so much thereof as may be necessary, are used
8 solely for the purpose specified in this act, and that
9 no obligations are incurred in excess of the sum
10 appropriated. The authority of the allottee to obligate
11 funds appropriated by this act shall lapse as of
12 September 30, 1985."

13 Section 3. This act shall become law upon approval by the
14 President of the Federated States of Micronesia or upon its
15 becoming law without such approval.
