THIRD CONGRESS OF THE FEDERATED STATES OF MICRONESIA

FOURTH SPECIAL SESSION, 1985

CONGRESSIONAL BILL NO. 3-380, C.D.1, C.D.2

AN ACT

To further amend section 1 of Public Law No. 3-57, as amended by Public Law No. 3-62, for the purpose of reapportioning funds appropriated for public projects in the State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 3-57, as amended by Public
2 Law No. 3-62, is hereby further amended to read as follows:

3 "Section 1. Appropriation. The sum of \$720,000, or so much
4 thereof as may be necessary, is hereby appropriated from the
5 General Fund of the Federated States of Micronesia for the
6 fiscal year ending September 30, 1985, for the purpose of
7 funding public projects in the State of Pohnpei. The sum
8 appropriated herein shall be apportioned as follows:


