

TWELFTH CONGRESS OF THE FEDERATED STATES OF MICRONESIA

SECOND REGULAR SESSION, 2001

CONGRESSIONAL BILL NO. 12-72, C.D.1

AN ACT

To further amend Public Law No. 10-143, as amended, by amending section 2 to change the use of Pohnpei Election District No. 1 funds, by amending section 5 to change an allottee for certain funds appropriated for Chuuk State and to remove a consultation requirement, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 10-143, as amended by
2 Public Law No. 12-5, is hereby further amended to read as follows:

3 "Section 2. The sum of \$600,000, or so much thereof as may
4 be necessary, is hereby appropriated from the General Fund of
5 the Federated States of Micronesia for the fiscal year ending
6 September 30, 1999, for the purpose of meeting the needs of
7 primary and secondary public schools, providing graduate
8 student scholarships, State hospitals and State administered
9 public health programs, and other social and economic
10 development projects and programs in the State of Pohnpei.
11 The funds appropriated by this section for educational,
12 hospital and public health purposes, shall not be disbursed
13 for salaries, travel, training, or vehicles. The funds
14 appropriated under this section shall be apportioned as
15 follows:

16 (1) Election District No. 1

17 (a) Graduate student scholarships for
18 students from Election District No. 1.....\$ 10,000

1	(b) Agriculture Day promotional	
2	contest in Kolonia.....	\$ 10,000
3	(c) Election District No. 1 project	
4	implementation administrative expenses.....	10,000
5	(d) Other educational, hospital and	
6	public health purposes.....	170,000
7	(2) Election District No. 2.....	200,000
8	(3) Election District No. 3.....	200,000"

9 Section 2. Section 5 of Public Law No. 10-143 is hereby amended
10 to read follows:

11 "Section 5. Allotment and management of funds and lapse
12 date.

13 (1) All funds appropriated by this act shall be allotted,
14 managed, administered, and accounted for in accordance with
15 applicable law, including, but not limited to, the Financial
16 Management Act of 1979. The allottee of the funds
17 appropriated under section 1(1) of this act shall be the
18 Executive Director of the Mortlocks Development Commission.
19 The allottee of the funds appropriated under section 1(2) of
20 this act shall be the Executive Director of the Northern
21 Namoneas Development Authority or his designee. The allottee
22 of the funds appropriated under section 1(3) of this act
23 shall be the Executive Director of the Chuuk State Commission
24 on Improvement Projects. If the Chuuk State Commission on
25 Improvement Projects shall be abolished pursuant to Chuuk

1 State law, the Chuuk State Commission on Improvement Projects
2 shall be deemed to be, and shall be treated as, a continuing
3 entity for the purposes of this measure. The allottee of the
4 funds appropriated under section 1(4) of this act shall be
5 the Mayor of Polle. The allottee of the funds appropriated
6 under section 1(5) of this act shall be the Northwest Islands
7 Project Coordinator or his designee. The allottee of the
8 funds appropriated under section 1(6) of this act shall be
9 the Secretary of the Department of Health, Education and
10 Social Affairs of the Federated States of Micronesia, or his
11 designee. The allottee of the funds appropriated under
12 section 3 of this act shall be the Governor of the State of
13 Yap or the Governor's designee. The allottee of the funds
14 appropriated under section 4 of this act shall be the
15 Governor of the State of Kosrae or the Governor's designee.
16 The allottee of all other funds appropriated by this act
17 shall be the President of the Federated States of Micronesia
18 or the President's designee. The allottees shall be
19 responsible for ensuring that these funds, or so much thereof
20 as may be necessary, are used solely for the purpose
21 specified in this act, and that no obligations are incurred
22 in excess of the sum appropriated.

23 (2) The authority of the allottees to obligate funds
24 appropriated by this act shall not lapse."

25 Section 3. This act shall become law upon approval by the

1 President of the Federated States of Micronesia or upon its becoming
2 law without such approval.
