A RESOLUTION

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 WHEREAS, His Excellency Bailey Olter, the former President of
- 2 the Federated States of Micronesia, passed away on February 16th,
- 3 1999; and
- 4 WHEREAS, Bailey Olter ably and humbly served the people of this
- 5 Nation throughout his lifetime in many leadership roles; and
- 6 WHEREAS, Bailey Olter was a significant political leader during
- 7 the Nation's formative years, in particular as a representative in
- 8 our first Constitutional Convention and as a vice chairman of the
- 9 Commission on Future Political Status and Transition; and
- 10 WHEREAS, Bailey Olter's contribution as a leader continued
- 11 through his service as Senate Vice President in the First Congress
- 12 through the Third Congress of Micronesia and as Chairman of the
- 13 Senate Committee on Ways and Means from the Second Congress through
- 14 the Sixth Congress of Micronesia; and
- WHEREAS, Bailey Olter was elected to the Congress of the
- 16 Federated States of Micronesia and was the Nation's second Vice
- 17 President; and
- WHEREAS, His Excellency Bailey Olter was elected to the Office
- 19 of the President of the Federated States of Micronesia in 1991 as
- 20 our Nation's third President, which Office he held for six years,
- 21 having been re-elected in 1995; and
- WHEREAS, Bailey Olter's many and varied contributions to our
- 23 Nation are innumerable, particularly in the political arena where he
- 24 was a concerned and steadfast believer in the development of the
- 25 Federated States of Micronesia as a Nation, and where he used his

1 skills to help develop and implement our Constitution and promote

- 2 unity among the States in order to strengthen the bonds of
- 3 nationhood; and
- WHEREAS, Bailey Olter was also a teacher and businessman who
- 5 strove for excellence in those pursuits; and
- 6 WHEREAS, as important as were the contributions made by Bailey
- 7 Olter throughout his lifetime, as a Leader and Statesman, Bailey
- 8 Olter was also a husband, father and grandfather, who by all
- 9 accounts will be sorely missed and mourned by his beloved wife,
- 10 Amalia Olter, their eight children, grandchildren and other family
- 11 members; now, therefore,
- BE IT RESOLVED by the Tenth Congress of the Federated States of
- 13 Micronesia, Fourth Special Session, 1999, that the Members of the
- 14 Tenth Congress hereby respectfully convey their sorrow, bereavement
- 15 and sincere condolences on their own behalf and on behalf of the
- 16 people of the Federated States of Micronesia, to Mrs. Amalia Olter,
- 17 the widow of His Excellency Bailey Olter, and to his family, on the
- 18 passing of our beloved Leader and Statesman; and
