A BILL FOR AN ACT

To further amend Public Law No. 10-120, as amended, by further amending section 1, as amended by Public Laws Nos. 10-122, 10-144, 11-8, and 11-20, and by further amending section 6, as amended by Public Laws Nos. 10-122, 11-8, and 11-10, to further break down and to change the allottee for certain Chuuk Election District No. 3 funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 10-120, as amended by
2 Public Laws Nos. 10-122, 10-144, 11-8, and 11-20, is hereby further
3 amended to read as follows:

4 "Section 1. The sum of \$5,000,000, or so much thereof as
5 may be necessary, is hereby appropriated from the General
6 Fund of the Federated States of Micronesia for the fiscal
7 year ending September 30, 1999, for the purpose of
8 funding infrastructure and other projects and programs in
9 the State of Chuuk. The funds appropriated under this
10 section shall be apportioned as follows:

- 11 (1) Regional transportation projects (which shall be
- 12 deemed to come from capital account funds available under
- 13 section 211 of the Compact of Free Association)
- 14 (a) Ta airport paving and related
- 15 structures and equipment..... \$ 200,000
- 16 (b) Houk airport paving, including
- 17 acquisition of related structures and
- 18 equipment..... 250,000
- 19 (c) Chuuk International Airport
- 20 construction and repair..... 50,000
- 21 (2) Chuuk Delegation Office 100,000
- 22 (3) At-large projects
- 23 (a) Rural water program 15,000
- 24 (b) Youth community programs 17,000
- 25 (c) Chuuk 4H Youth Baseball League .. 10,000

25	Section 2. Section 6 of Public Law No. 10-120, 'as amended by

1 Public Laws Nos. 10-122, 11-8, and 11-10, is hereby further amended
2 to read as follows:

3 "Section 6. Allotment and management of funds and lapse
4 date.

5 (1) All funds appropriated by this act shall be
6 allotted, managed, administered, and accounted for in
7 accordance with applicable law, including, but not
8 limited to, the Financial Management Act of 1979. The
9 allottee of the funds appropriated under section 1(3)(e)
10 of this act shall be the Governor of the State of Chuuk
11 or his designee. The allottee of the funds appropriated
12 under section 1(2) of this act shall be the Speaker of
13 the Congress of the Federated States of Micronesia. The
14 allottee of the funds appropriated under section 1(3)(a)
15 of this act shall be the Director of the Department of
16 Health Services. The allottee of the funds appropriated
17 under section 1(3)(c) of this act shall be the Assistant
18 Director, Land Grant Program, Cooperative Extension
19 Services, Chuuk State. The allottee of the funds
20 appropriated under section 1(3)(d) of this act shall be
21 the Executive Director of the Chuuk Recreation Office.
22 The allottee of the funds appropriated under sections
23 1(3)(f) and 1(3)(g) of this act shall be the Secretary of
24 the Department of Health, Education and Social Affairs of
25 the Federated States of Micronesia, or his designee. The

1 allottee of the funds appropriated under section 1(4) of
2 this act shall be the Mortlocks Development Authority, or
3 if the Mortlocks Development Authority shall be
4 abolished, the Project Coordinator for the Mortlocks or
5 his designee. The allottee of the funds appropriated
6 under sections 1(5) and 1(3)(b) of this act shall be the
7 Executive Director of the Northern Namoneas Development
8 Authority, or if the Northern Namoneas Development
9 Authority shall be abolished, the Northern Namoneas
10 Project Coordinator or his designee. The allottee of the
11 funds appropriated under section 1(6)(a) and 1(6)(b) of
12 this act shall be the Executive Director of the Chuuk
13 State Commission on Improvement Projects. The allottee
14 of the funds appropriated under section 1(6)(c) of this
15 act shall be the Executive Director of the Southern
16 Namoneas Development Authority. If the Southern Namoneas
17 Development Authority shall be abolished pursuant to
18 Chuuk State law, the Southern Namoneas Development
19 Authority shall be deemed to be, and shall be treated as,
20 a continuing entity for the purposes of this measure.
21 The allottee of the funds appropriated under section 1(7)
22 of this act shall be the Mayor of Polle. The allottee of
23 the funds appropriated under section 1(8)(a) of this act
24 shall be the Northwest Islands Project Coordinator or his
25 designee. The allottee of the funds appropriated under

1 section 1(8)(b) of this act shall be the General Manager,
2 Northwest Financial Services. The allottee of the funds
3 appropriated under section 2(1) of this act shall be the
4 respective mayor of each municipality listed therein.
5 The allottee of the funds appropriated under sections
6 2(2) through 2(8) of this act shall be the Governor of
7 the State of Kosrae. The allottee of the funds
8 appropriated under section 2(9) of this act shall be the
9 President of the Federated States of Micronesia, or the
10 President's designee. The allottee of the funds
11 appropriated under section 3(1)(a) of this act shall be
12 the Mayor of Kolonia Town, and said allottee shall
13 obligate no more than \$3,000 of such funds for
14 administrative costs. The allottee of the funds
15 appropriated under sections 4(1) through 4(7) and 4(9)
16 through 4(18) of this act shall be the Governor of the
17 State of Yap. The allottee of the funds appropriated
18 under section 4(8) of this act shall be the Speaker of
19 the Congress of the Federated States of Micronesia. The
20 allottee of all other funds appropriated by this act
21 shall be the President of the Federated States of
22 Micronesia or the President's designee. In the event
23 that the President designates the Vice President as
24 allottee, the Vice President may designate a suballottee.
25 The allottees shall be responsible for ensuring that



1 these funds, or so much thereof as may be necessary, are
 2 used solely for the purpose specified in this act, and
 3 that no obligations are incurred in excess of the sum
 4 appropriated. No allottee of funds appropriated under
 5 section 2(1) of this act shall obligate funds without
 6 first consulting with the members of the Kosrae
 7 delegation to the Congress of the Federated States of
 8 Micronesia. The allottee of funds under section 3(2) of
 9 this act shall not obligate funds without first
 10 consulting with the member of the Congress of the
 11 Federated States of Micronesia representing that
 12 district, and said allottee shall obligate no more than
 13 ten percent of such funds for administrative costs.

14 (2) The authority of the allottees to obligate funds
 15 appropriated by this act shall lapse as of September 30,
 16 2001."

17 Section 3. This act shall become law upon approval by the
 18 President of the Federated States of Micronesia or upon its becoming
 19 law without such approval.
