A BILL FOR AN ACT

To further amend Public Law No. 10-119, as amended, by further amending section 11, as amended by Public Laws Nos. 10-130 and 10-139, to transfer \$30,000 from the "Personnel" line to the "Contractual services" line within the budget of the Joint Committee on Compact Economic Negotiations, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 11 of Public Law No. 10-119, as amended by
2 Public Laws Nos. 10-130 and 10-139, is hereby further amended to
3 read as follows:

4 "Section 11. Other National Government programs, grants,
5 subsidies, contributions, and refunds. The sum of
6 \$4,505,184, or so much thereof as may be necessary, is
7 hereby appropriated from the General Fund of the
8 Federated States of Micronesia for the fiscal year ending
9 September 30, 1999, for special programs, grants,
10 subsidies, contributions, and refunds of the National
11 Government of the Federated States of Micronesia during
12 fiscal year 1999. The sum appropriated by this section
13 shall be apportioned as follows:


