A BILL FOR AN ACT

To further amend Public Law No. 10-119, as amended, by further amending section 11, as amended by Public Law No. 10-130 and 10-139, for the purpose of reprogramming funding, thereby modifying the use of funds appropriated therein for the State of Yap, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 11 of Public Law No. 10-119, as amended by  
2 Public Law No. 10-130 and 10-139, is hereby further amended to read  
3 as follows:

4 "Section 11. Other National Government programs, grants,  
5 subsidies, contributions, and refunds. The sum of  
6 \$4,505,184, or so much thereof as may be necessary, is  
7 hereby appropriated from the General Fund of the  
8 Federated States of Micronesia for the fiscal year ending  
9 September 30, 1999, for special programs, grants,  
10 subsidies, contributions[7] and refunds of the National  
11 Government of the Federated States of Micronesia during  
12 fiscal year 1999. The sum appropriated by this section  
13 shall be apportioned as follows:

- 14 (1) Special programs:
  - 15 (a) FSM Aquaculture Center.....\$ 120,400
  - 16 (b) Joint Committee on Compact Economic
  - 17 Negotiations (JCN)
    - 18 (i) Wages and salaries of JCN
    - 19 personnel, none of which may be used to pay
    - 20 claims for overtime compensation ..... 191,600
    - 21 (ii) Housing allowances ..... 10,500
    - 22 (iii) Travel ..... 60,068
    - 23 (iv) Contractual services
      - 24 a) Retainer fees ..... 150,000
      - 25 b) Representation ..... 20,000


