A BILL FOR AN ACT

To further amend title 52 of the Code of the Federated States of Micronesia, as amended, by repealing section 205 in its entirety, and by adding a new section 205 in lieu thereof, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Title 52 of the Code of the Federated States of
2 Micronesia, as amended, is hereby further amended by repealing
3 section 205 in its entirety and adding a new section 205 to read as
4 follows.



1 The provisions of this schedule shall not operate to decrease the
2 base salary biweekly rate of employees employed on the effective
3 date of the amending act codified in this section. Furthermore, the
4 base salary biweekly rate of such employees shall not be increased
5 beyond the rate in effect on the effective date of the amending act
6 codified in this section."

7 Section 2. This act shall become law upon approval by the
8 President of the Federated States of Micronesia or upon its becoming
9 law without such approval.
