

A BILL FOR AN ACT

To further amend Public Law No. 11-59, as amended, by amending section 7 to extend the lapse date of certain funds [~~appropriated under section 4 for infrastructure and other projects and programs in the State of Yap~~], and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1           Section 1. Section 7 of Public Law No. 11-59, as amended by  
2 Public Laws Nos. 11-69, 11-79, 12-7 and 12-33, is hereby further  
3 amended to read as follows:

4           "Section 7. Allotment and management of funds and lapse  
5           date.

6           (1) All funds appropriated by this act shall be  
7 allotted, managed, administered, and accounted for in  
8 accordance with applicable law, including, but not  
9 limited to, the Financial Management Act of 1979. The  
10 allottee of the funds appropriated under subsection (1)  
11 of section 1 of this act shall be the Chairman of the  
12 Coordination Committee of the Kosrae State 2001 Summer  
13 Youth Conference. The allottee of the funds  
14 appropriated under subsections (2), (4), (5), (10) and  
15 (11) of section 1 of this act shall be the Secretary of  
16 the Department of Finance and Administration, or his  
17 designee. The allottee of the funds appropriated under  
18 subsection (3) of section 1 and the funds appropriated  
19 under section 6 of this act shall be the Governor of the

1 State of Kosrae, or his designee. The allottees of the  
2 funds appropriated under subsections (6) through (9) of  
3 section 1 of this act shall be the Mayors of the  
4 respective towns or municipalities. The allottee of the  
5 funds appropriated under sections 2 and 5 of this act  
6 shall be the President of the Federated States of  
7 Micronesia, or his designee. The allottee of the funds  
8 appropriated under section 3 of this act shall be the  
9 Chuuk State Commission on Improvement Projects, EXCEPT  
10 THAT the allottee of the funds appropriated under  
11 subsection (2) (b) of section 3 of this act shall be the  
12 Vice President of the Federated States of Micronesia, or  
13 his designee; and the allottee of the funds appropriated  
14 under subsection (6) of section 3 of this act shall be  
15 the Northwest Project Coordinator. The allottee of the  
16 funds appropriated under subsections (1) through (13)  
17 and subsection (15) of section 4 of this act shall be  
18 the Governor of the State of Yap, or his designee. The  
19 allottee of the funds appropriated under subsection (14)  
20 of section 4 of this act shall be the Speaker of the  
21 Congress of the Federated States of Micronesia, or his  
22 designee. The allottees shall be responsible for  
23 ensuring that the funds appropriated by this act, or so  
24 much thereof as may be necessary, are used solely for  
25 the purpose specified in this act, and that no

1 obligations are incurred in excess of the sum  
2 appropriated.

3 (2) The authority of the allottees to obligate funds  
4 appropriated by this act shall lapse as of September 30,  
5 ~~[2002]~~ 2005; EXCEPT THAT the authority of the allottee  
6 to ~~[obligate funds appropriated under [subsection (1) of~~  
7 ~~section 4 of this act shall lapse as of September 30,~~  
8 ~~2003]~~ section 4 of this act shall lapse as of September  
9 30, 2005 and the authority of the allottee to obligate]  
10 obligate funds appropriated under subsection (10) of  
11 section 1 of this act shall not lapse."

12 Section 2. This act shall become law upon approval by the  
13 President of the Federated States of Micronesia or upon its  
14 becoming law without such approval.
