## A RESOLUTION

Authorizing and requesting the President, or his designee, to sign and execute that certain Deed of Conveyance conveying real property consisting of approximately 2,384 square meters in exchange for the conveyance in Fee Simple to the National Government of the Federated States of Micronesia real property consisting of approximately 19,908 square meters.

- 1 WHEREAS, it is the intentions of this Congress to encourage and
- 2 promote understanding and cooperation between the States and
- 3 National Government in the accomplishment of mutually desirable and
- 4 beneficial goals and objectives; and
- 5 WHEREAS, it is the desire of this Congress to assist the States
- 6 whenever possible in meeting the needs of its populace, through the
- 7 ongoing consistent operation of its governmental departments and
- 8 agencies; and
- 9 WHEREAS, the State of Chuuk, through its Governor, the
- 10 Honorable Ansito Walter, requested the transfer and exchange of
- 11 properties owned by the State of Chuuk and the Federated States of
- 12 Micronesia to allow for the continued uninterrupted operations of
- 13 the State of Chuuk's Agricultural Department which was operating on
- 14 such lands owned by the Federated States of Micronesia as were
- 15 previously purchased for construction of a National Government
- 16 office complex and to house the CFSM Chuuk Delegation offices; and
- WHEREAS, on June 24, 1999, the State of Chuuk executed a Deed
- 18 of Conveyance, conveying in Fee Simple to the Federated States of
- 19 Micronesia, for and in consideration of One Dollar and other
- 20 valuable consideration, such real property owned by the State of
- 21 Chuuk and being more properly described as Lot No. 035-A-04 known as
- 22 Apichon situated in the Registration Area No. 2 as shown on the
- 23 Division of Lands Surveys Official Cadastral Plat Number 035-A-00
- 24 dated February 21, 1973, and containing an area of 19,908 square
- 25 meters, more or less, and including any, and together with all,

- 1 hereditaments and appurtenances for the purpose of providing a
- 2 location for the construction of a federal office complex, and with
- 3 the understanding that the Federated States of Micronesia would
- 4 execute a Deed of Conveyance conveying in Fee Simple that certain
- 5 land presently utilized by the State of Chuuk Agricultural
- 6 Department; and
- WHEREAS, on June 29, 1999, the State of Chuuk in good faith
- 8 caused to be executed and delivered a Certificate of Title
- 9 confirming the conveyance of Fee Simple ownership in the Federated
- 10 States of Micronesia of the aforementioned land consisting of 19,908
- 11 square meters, more or less; now, therefore,
- 12 BE IT RESOLVED by the Eleventh Congress of the Federated States
- 13 of Micronesia, First Special Session, 1999, that the President be
- 14 authorized and requested to sign and execute that certain Deed of
- 15 Conveyance conveying in Fee Simple to the State of Chuuk, for and in
- 16 consideration of One Dollar and other valuable consideration, such
- 17 real property owned by the Federated States of Micronesia, and
- 18 located in the State of Chuuk, being more properly described as Lot
- 19 No. 928-A-27 known as Nosapwin #1 part located in Iras Village,
- 20 Weno, Chuuk State as shown on Division of Lands Surveys Official
- 21 Cadastral Plat Number 928-A-02 dated January 9, 1986, and containing
- 22 an area of 2,384 square meters, more or less, and including any, and
- 23 together with all, hereditaments and appurtenances; and
