A RESOLUTION

To ratify the Amendments to the Articles of Agreement establishing the Treaty on Fisheries between the Governments of Certain Pacific Island States and the Government of the United States, as amended.

- WHEREAS, the Treaty on Fisheries between the Governments of
- Certain Pacific Island States and the Government of the United
- States (hereinafter referred to as the Multilateral Fisheries
- Treaty) was ratified by the Congress of the Federated States of
- Micronesia on May 29, 1987; and
- 6 WHEREAS, amendments to the Annexes of the Multilateral
- Fisheries Treaty entered into force on June 15, 1993, and the
- Multilateral Fisheries Treaty as amended is scheduled to remain in
- 9 force for ten years; and
- 10 WHEREAS, the twelfth licensing period of the Multilateral
- Fisheries Treaty will commence June 15, 1999; and
- 12 WHEREAS, the Pacific Island Parties to the Treaty met in March,
- 13 1999, and agreed to make every effort to seek entry into force by
- June 14, 1999, of amendments to the Treaty and to Schedules 2 and 3
- of Annex I to the Treaty, as proposed by the United States, the 15
- 16 Solomon Islands and Papua New Guinea; and
- WHEREAS, the amendment to Article 3.2 of the Treaty, as 17
- proposed by the United States, would permit United States longline
- vessels to fish on the high seas areas within the Treaty Area; and
- 20 WHEREAS, the amendment to Schedules 2 and 3 of Annex I of the
- 21 Treaty, as proposed by the Solomon Islands, seeks to open up
- 22 previously closed areas within the national jurisdiction of the
- Solomon Islands to United States vessels operating under the Treaty; 23

- WHEREAS, the amendment to Schedule 2 of Annex I, as proposed by 25

1 Papua New Guinea, would prohibit fishing by United States vessels 2 within the archipelagic waters, territorial sea and internal waters 3 under the national jurisdiction of Papua New Guinea; and WHEREAS, the proposed amendments to the Treaty and to Schedules 5 2 and 3 of Annex I do not compromise the interests of the Federated 6 States of Micronesia; and WHEREAS, the Multilateral Fisheries Treaty as amended is in the best interest of the FSM National Government; now, therefore, BE IT RESOLVED by the Eleventh Congress of the Federated States 10 of Micronesia, First Regular Session, 1999, that pursuant to section 11 2(b) of article IX of the Constitution of the Federated States of 12 Micronesia the Congress hereby ratifies the Amendments to the 13 Articles of Agreement establishing the Treaty on Fisheries between 14 the Governments of Certain Pacific Island States and the Government 15 of the United States, which agreement shall remain in effect until 16 June 14, 2003; and 17 BE IT FURTHER RESOLVED that certified copies of this resolution be transmitted to the President of the Federated States of 18 19 Micronesia and the Director of the Forum Fisheries Agency. 20 Date: 5/18/99 Introduced by: _
